Question:	

It is stated in Matters Requiring Special Attention in 2016-17 that the Home Affairs Bureau will continue to implement and review the effectiveness of the feeder system scheme for early identification and development of young potential athletes. In this connection, will the Government inform this Committee of the following:

- (a) Regarding the implementation of the feeder system scheme, what are the expenditures earmarked in the estimates for 2015-16 for each of the "national sports associations" (NSAs) and how effective is the work? What are the mechanism and criteria used by the Government in assessing the effectiveness of the provision? What are the estimated expenditures for each of the NSAs this year? What is the specific work plan?
- (b) Apart from providing subventions to NSAs, what measures are taken by the Government to support the implementation of the feeder system for other sports? What are the estimated expenditures involved?
- (c) Regarding the Pilot Scheme for Student Athlete Support introduced in the 2013/2014 school year, what is the participation rate of schools in the 2015/2016 school year? How many student athletes have been benefited? What is the estimated expenditure for the 2016/2017 school year? When will the Government review the scheme?

Reply:

(a) & (b) In 2015-16, the Leisure and Cultural Services Department (LCSD) provided \$16.3 million for the Feeder System Scheme to support 52 national sports associations (NSAs) of different sports to implement their feeder programmes. A breakdown of the subvention granted to individual NSAs for feeder programmes in 2015-16 is at the Annex.

The LCSD has assessed the effectiveness of the scheme in terms of achievement of performance targets set by the NSAs, including the organisation of feeder programmes, recruitment of squad members, and athletes' achievements in international sports competitions. Since its launch in 2009-10, the scheme has achieved very good results. As at December 2015, the scheme has resulted in the identification of 1 613 athletes for promotion to higher level squads for further training. Of these, 451 have been promoted to junior squads of different sports. The LCSD will continue to monitor the effectiveness of the scheme.

In 2016-17, the total funding earmarked to support 52 NSAs to implement feeder programmes will be around \$16.4 million and the amount to be allocated to the individual NSAs is being finalised. The programmes to be implemented under the scheme will mainly include development programmes, talent identification, regional and junior squad training, local competitions, overseas training and competitions.

(c) In the 2015-16 school year, the number of participating schools of the Pilot Scheme for Student Athlete Support (the Pilot Scheme) has increased by around 18 per cent from the 2014-15 school year to 578 schools and we have earmarked \$6.94 million for allocation to the schools under the Pilot Scheme. Information on the number of beneficiaries will be available at the end of the school year upon receipt of the reports submitted by participating schools. As applications for the 2016-17 school year will be invited later this year, the relevant estimated expenditure is not yet available.

We will consider the way forward for the Pilot Scheme in the light of the reports received from the participating schools.
