Question:

The Leisure and Cultural Services Department has removed the estimated number of squash courts in the Estimates for the main reason that most of the squash courts in the sports centres managed by the Department have been converted into multi-purpose rooms. Please provide the following information:

(1) the usage of the squash courts in each of the sports centres in the territory shown in the table below.

- (2) Is it expected that all squash courts will be used as multi-purpose rooms since the Department has stopped providing the estimated number of squash courts from this year?
- (3) Does the Department think that the low usage rates of squash courts are related to the low effectiveness of its measures to promote the sport of squash?

Reply:

- (1) As at 1 January 2016, there were 212 squash courts inside the sports centres managed by the Leisure and Cultural Services Department (LCSD). Among them, 191 (90.1%) courts allowed multi-purpose use, including 154 courts which could be used for squash and other activities. The usage rates of these 212 courts in 2015 are set out at the <u>Annex</u>. The LCSD does not have breakdown on the usage rate for squash activities only.
- (2) & (3) The LCSD opens up those squash courts with persistently low usage for multi-purpose use with a view to ensuring optimal utilisation of valuable resources, enhancing flexibility in usage and meeting the changing community demand for sports facilities.

In the meantime, the LCSD will continue to implement a series of measures to promote the sports of squash. Schools, subvented non-government organisations, national sports association and district sports associations are allowed for free use of squash courts during non-peak hours. Moverover, people with disabilities can enjoy concessionary rates in the use of courts at all times while citizens aged 60 or above and students can enjoy concessionary rate for the use of squash courts during non-peak hours. In addition, the LCSD will continue to organise large-scale promotional activities such as the Sport For All Day, as well as fun days, training courses and competitions, to promote the use of squash courts. Promotional materials will be distributed to schools and local organisations to encourage them to use the facilities.
