Question:

The work of the Leisure and Cultural Services Department in operating museums is to provide a balanced mix of programmes for enhancing public appreciation of arts and culture. Please inform this Committee of the following with a breakdown by fee-charging museums across Hong Kong:

- (a) What are the actual and estimated staff establishments of each museum in the 2015-16 and 2016-17 financial years?
- (b) What is the total expenditure of each museum in the 2015-16 financial year?
- (c) What is the estimated expenditure of each museum in the 2016-17 financial year?
- (d) What are the attendance figures for each museum on free admission days, weekdays and holidays in the 2015-16 financial year?
- (e) It is noted that the Department has launched in recent years a series of promotional activities targeted at tourists to promote the museums as tourist attractions. Please provide information on these activities including the details and expenditure involved.
- (f) According to the Reply (HAB237) made during last year's Examination of Estimates of Expenditure, the Department indicated that tourists accounted for 27% of the visitors to the museums in 2013-14. With the launching of the promotional activities targeted at tourists in recent years, is there any increase in the number of visits by tourists in 2014-15?

Reply:

(a) to (c) The staff establishment and the estimated recurrent expenditure (excluding staff salaries) of the museums under the Leisure and Cultural Services Department (LCSD) in 2015-16 and 2016-17 are set out at **Annex**.

(d) The attendance figures of the 7 fee-charging museums on free admission days, weekdays, weekends and public holidays in 2015-16 (as at 29 February 2016) are set out below:

- (e) The LCSD has been promoting its museums to tourists through a variety of channels, such as e-platforms, placing advertisements and displays at tourist spots, distribution of museum guides at hotels, etc. Thematic exhibitions have regularly been mounted at the Passengers Terminal of the Hong Kong International Airport in recent years. Promotional videos are also broadcast in Airport Express and YouTube channels. The LCSD has been maintaining close liaison with the Hong Kong Tourism Board (HKTB) to provide them with up-to-date museum attractions, and Travellers' Map for distribution at HKTB's Visitors Centres and local hotels. A series of museum souvenirs are also on sale and displayed at major tourist spots, trade fairs and online platforms for leisure and business The expenditure in 2015-16 for the above promotional initiatives was travellers. \$1.24 million.
- (f) The LCSD conducts large scale opinion survey on LCSD museum services every 3 to 4 years. The profile and characteristics of local and foreign visitors are gauged in the survey. The last survey was conducted in 2013-14 which indicated that tourist visitors accounted for 27% of the visitors to museums. The next survey will be carried out in 2017 and the result would be available by the end of 2017.
