Reply:

(a) According to Rule 49 of the Finance Committee Procedures, special meetings of the Finance Committee are convened to examine the annual Estimates of Expenditure prepared by the Government in support of the Appropriation Bill.

(b) Expenditure charged to the Capital Works Reserve Fund do not form part of the Appropriation Bill. As such, questions relating to expenditure under the Fund are not relevant to the examination of the Estimates of Expenditure or the Appropriation Bill.

The Government has earmarked a total of \$20 billion in 2017 to launch 26 projects in the coming 5 years to develop new or improve existing sports and recreation facilities in different districts. The 26 projects and the major facilities to be provided therein are set out in paragraph 219 of the Policy Address announced in January 2017. We have consulted/are planning to consult the relevant Legislative Council (LegCo) panels and seek the funding approval of the Finance Committee (FC) for the following 10 projects in 2017-18 legislative year –
