<u>Question</u>:

- 1) What were the numbers of logins, browses and loans for e-book collections in the past 3 years?
- 2) What were the sizes of the library stocks and the number of titles available for browses/loan in the past 3 years?
- 3) What were the annual expenditures on the acquisition of e-book copyrights and the promotion of e-book services in the past 3 years? Does the Department have any plan to promote the use of e-resources, particularly e-book services?

Reply:

- 1) The usage statistics of e-book collections of the Hong Kong Public Libraries (HKPL) in the past 3 years are at <u>Annex</u>.
- 2) The number of items of print and non-print physical materials of the HKPL in the past 3 years is set out below. All library materials are available for browses/loan at individual libraries.

3) The expenditures on the acquisition and subscription of e-book collections in 2015-16 and 2016-17 were \$3.5 million and \$4.2 million respectively. The estimated expenditure in 2017-18 is \$4.0 million.

The HKPL will continue to promote the e-book collections to various sectors of the community by regularly organising education and extension activities, library visits by schools/organisations, briefing sessions on electronic information and "School Culture Day"; and through customer liaison groups, teacher liaison groups as well as paying visits to schools/community groups/organisations. The HKPL will launch an on-line Reading Charter in celebration of the World Book Day in April 2018 to further promote reading to the community at large. The cost will be absorbed within the recurrent expenditure of the Leisure and Cultural Services Department.

Hong Kong Public Libraries (HKPL) Usage of e-Book Collections (2015-2017)
