- (2) Including additional time-limited funding for commissioning creative works and performances by local arts groups and artists during the Festival.
- (b) HKAFS is a non-profit-making and financially autonomous organisation in which the government subvention is only one of its sources of revenue. The Government does not have the requested information on the breakdown of expenditures for HKAFS.
- (c) The Government has announced in the 2018-19 Budget that it will provide a total of \$40 million in the coming 5 years to HKAFS for commissioning creative works and performances by local arts groups and artists during the Arts Festival. With the additional funding, HKAFS will help local arts groups/artists reach out to a wider audience, further develop the community arts, and extend its programmes to more performing arts venues in the New Territories. Proposed programme details will be worked out later.
