### Question:

The Leisure and Cultural Services Department is responsible for managing pet gardens. In this connection, will the Department inform this Committee of the following:

- 1. The locations of all pet gardens across the territory, their respective areas and facilities;
- 2. The locations of the pet gardens scheduled to be completed/opened within 2019-20, their respective areas and facilities.

Asked by: Hon KWOK Ka-ki (LegCo internal reference no.: 384)

### Reply:

- 1. As at March 2019, 49 leisure venues under the management of the Leisure and Cultural Services Department (LCSD) are provided with pet gardens. Latrine and/or excreta collection bins are provided therein. Some pet gardens are equipped with drinking fountains and play equipment for pets. A list of existing venues, by district, provided with pet gardens is at **Annex I**. In addition, LCSD launched a trial scheme to open up 6 parks for use by pet owners and their pets from 1 January 2019 with a view to providing an inclusive park environment for different users. The scheme will be reviewed 1 year after the implementation of the trial scheme.
- 2. LCSD plans to provide 2 more pet gardens in 2019. Ancillary facilities for pets may include latrine, excreta collection bins, drinking fountains, etc. A list of new pet gardens, by district, to be completed in 2019 is at **Annex II**.
