Question:

Please provide information on the following figures in the past 3 years:

- a. the number of enrolments for “Briefing on Proper Ways to Use Fitness Equipment” organised at sports centres in various districts;
- b. the average usage rate of fitness rooms in various districts;
- c. the number of fitness equipment repaired or procured and the expenditures involved in various districts;
- d. the number of Fitness Room Monthly Tickets purchased in various districts.

Reply:

- a. The number of participants for the “Briefing on Proper Ways to Use Fitness Equipment” organised at the sports centres managed by the Leisure and Cultural Services Department (LCSD) in the past 3 years is set out at **Annex I**.
- b. The attendance of fitness rooms by district in the past 3 years is set out at **Annex II**.
- c. The LCSD currently manages 101 sports centres, of which 78 are provided with fitness rooms. As most of the fitness rooms form part of the facilities provided in the sports centres, the LCSD does not have separate figures and expenditure on the maintenance or additional procurement of the fitness equipment.
- d. The number of fitness room monthly tickets sold in the past 3 years is tabulated below:
