Overall speaking, meal breaks or rest time is generally 30 to 60 minutes long. In addition, since the LCSD is not the employer of the outsourced workers and does not require the contractors to provide details of their employees, the LCSD does not have the details about the employment of outsourced workers (such as information on their length of service and age distribution).
