Regarding the Venue Partnership Scheme, please provide the following information:

- 1. The total number of activities organised under the Scheme and the total attendance in the past three years (i.e. from 2011-12 to 2013-14).
- 2. What kind of support is provided under the Scheme to local young artists? What is the annual expenditure involved? Please provide a breakdown by subvented/supported project.
- 3. In the past three years (i.e. from 2011-12 to 2013-14), how many small to medium-scale performing arts groups applied for subvention under the Scheme and how many applications were successful? What was the average amount of subvention granted for successful applications?

Reply:

1. Under the Venue Partnership Scheme (VPS) of the Leisure and Cultural Services Department (LCSD), which is implemented on a three-year term basis with the first term and second term running from 2009-10 to 2011-12 and 2012-13 to 2014-15 respectively, the number of activities organised by the Venue Partners (VPs) and the attendance from 2011-12 to 2013-14 (estimated) are as follows:

2. The support provided by the LCSD to all VPs include (i) priority use of the host venue's facilities; (ii) provision of work space; and (iii) enhanced publicity support such as publicity of the VP's events in the monthly event calendars and use of foyer display areas and wall banner sites at the host venues. In addition, the LCSD also provides those small and medium-sized VPs that are not subvented by the Home Affairs Bureau with an annual programme fee (up to \$1 million per group in 2011-12 and 2012-13, and up to \$1.1 million per group in 2013-14) to cover their production, staff and administrative costs, free use of the host venue and ticketing services. The total funding support provided by the LCSD (including notional venue charges and ticketing service) for the small and medium-sized VPs in 2011-12, 2012-13 and 2013-14 are \$22.8 million, \$31.3 million and \$32.4 million respectively. The breakdown is as follows:

3. In the first term of the VPS (2009-10 to 2011-12), 53 small and medium-sized performing arts groups applied singly or jointly for participation in the Scheme. 11 VPs comprising 26 small and medium-sized performing arts groups were selected. In the second term (2012-13 to 2014-15), 70 small and medium-sized performing arts groups submitted applications, and 13 VPs comprising 35 small and medium-sized performing arts groups are now taking part in the Scheme. The programme fees granted to each of the small and medium-sized VPs in 2011-12, 2012-13 and 2013-14 averaged at \$0.94 million, \$0.99 million and \$1.1 million respectively.
