#### 申請人須知 Notes to Applicants

- (1) 有關《個人資料(私隱)條例》(第486章)的須知 Notes Regarding the Personal Data (Privacy) Ordinance (Cap. 486)
  - (a) 收集資料的目的 Purposes of Collection

經這份申請表填報的個人資料,將由發牌當局用於下列用途: The personal data provided by means of this form will be used by the Licensing Authority for the following purposes:
