2. 參賽資格
Eligibility

- ：
- (1) 歡迎有興趣的工商機構(如有需要,大會有關要求報名機構提供有關證明,如有效的香港商業登記證)和政府部門以總公司/政府部門的名義參加。
Interested organisations (may be required to produce relevant supporting documents such as Business Registration Certificate) in the name of head office and the government departments are welcome to take part in the competition.
 - (2) 參賽者必須任職於該機構,年滿 15 歲並已為同一僱主連續工作 4 星期或以上,而每星期最少工作 18 小時,並在比賽進行期間,仍然受僱於該機構。
A participant should be an employee aged 15 or above who has been working continuously for an organisation for 4 weeks or more, for at least 18 hours each week and is still being employed by the same organisation during the competition period.
 - (3) 參賽者只能代表一間機構,如轉換代表機構,參賽者必須已離開前任職機構,並在該項比賽首場賽事進行時已在新代表的機構連續工作 4 星期或以上,而每星期最少工作 18 小時,並在比賽進行期間,仍然受僱於該機構。
Each participant can only represent one organisation. A participant may represent another organisation provided that he/she has resigned from the previous organisation and has been working continuously for the current organisation for not less than 4 weeks when the first match of the competition takes place, for at least 18 hours each week and is still being employed by the organisation during the competition period.

6. 賽制 : (1) 在截止報名後，如有任何組別／項目少於兩隊報名，該組別／項目將會取消。
Format If the number of teams enrolled in any group/division is less than two after the enrolment deadline, the group/division will be cancelled.
- (2) 甲、乙組初賽採分組單循環制，以 4 隊為 1 組，每組首名出線。出線隊伍再採分組單循環制進行複賽，以 3 隊為 1 組，每組首名出線。出線隊伍再採單淘汰制進行比賽。
丙組初賽採分組單循環制，以 4 隊為 1 組，每組首名出線。出線隊伍再採單淘汰制進行比賽。
(大會有權因應報名情況而更改有關組別／項目賽事的賽制。)
For Groups A and B, a single round robin system on group basis will be adopted in the preliminary round. Each group will consist of 4 teams. A single round robin system on group basis will be adopted again among each group's top teams in the intermediate round. Each group will consist of 3 teams. A Single knock-out system will be applied to matches among each group's top teams.
For Group C, a single round robin system on group basis will be adopted in the preliminary round. Each group will consist of 4 teams. A Single knock-out system will be applied to matches among each group's top teams.
(The Organiser reserves the right to change the format of competition for any group/division in consideration of the enrolment situation.)
- (3) 初賽分組編排由大會抽籤決定。
Grouping for matches in the preliminary round will be determined by lots drawing by the Organiser.
- (4) 全場比賽時間為 40 分鐘，上、下半場各 20 分鐘，中場休息 5 分鐘。
Each match will last 40 minutes, 20 minutes for the first half and 20 minutes for the second half, with 5 minutes' break in between.
- (5) 單淘汰制賽事每場均需分出勝負，賽和則各隊派 3 名球員互射九碼球。如仍未能分出勝負，則以「突然死亡」法互射九碼球定勝負。
In matches adopting the single knock-out system, a winning team must be identified for each match. If the match ends in a draw, each team shall assign 3 players to take the "9 yards" shoot-out alternately. If the winner is still not identified, the "Sudden Death" rule will be adopted to determine the winner.
- (6) 每隊全場最多可換球員 3 人，被換出的球員不得再參與該場比賽。
Not more than 3 players may be substituted during a match. Players who have been replaced will not be allowed to re-enter the match.
- (7) 本賽事不設越位。
The "off-side" rule will not be adopted in the competition.

7. 計分法
Point Scoring System : (1) 在單循環賽事中，每場勝方得 3 分，負方得 0 分，賽和各隊得 1 分。
In matches adopting the single round robin system, the winner gains 3 points and the loser gains no point. If the match ends in a draw, each team will gain 1 point.
- (2) 在單循環賽事中，若兩隊或以上隊伍積分相同，則以有關隊伍全部賽事的得失球差額（即得球減失球）決定名次。如仍未分出名次，則以得球較多的隊伍列於較前名次。如仍然相同，則以有關隊伍對賽成績勝者為勝。如該場賽和，則抽籤決定勝負。
If two or more teams score the same points in matches adopting the single round robin system, the positions will be determined by the goal difference of the teams involved in all matches (calculated by subtracting goals conceded from goals scored). If the goal differences are equal, the team scoring more goals will be placed in the higher position. If the number of goals scored are equal, the winner will be the win side of a match between the teams involved. If the match ends in a draw, the positions will be determined by lots drawing.
8. 賽則
Rules : 除本章程明文規定外，其餘均依照九龍小型足球總會的現行比賽規則辦理。
Unless explicitly stated in this prospectus, all rules and regulations will follow those presently adopted by the Kowloon Miniature Football Association Limited.
9. 職員／參賽者須知
Notes to Staff

- (2) 每隊可填報領隊／教練一名及球員 20 名。
Each team can submit a list of one team leader / coach and 20 players.
- (3) 於 2012 年 3 月 5 日後，所有參賽隊伍均不得再改動隊員名單。如有隊員辭職或受傷，而有關機構欲改動隊員名單，便須提出書面申請，並提交受傷隊員的醫生證明書，大會才會因應個別情況作出考慮。
Any change of team members is not allowed after 5 March 2012. In case of resignation or injury of any team member, application for change of team members will only be considered on a case by case basis provided that the application is made in a written form and attached with the medical certificate(s) of the injured person(s).
- (4) 球賽開始前 15 分鐘，雙方領隊或教練須填妥出場表，連同球員的身份證明文件交予該場比賽幹事核對，未能出示有效身份證明文件的球員，不得出賽。
The team leaders/coaches of both teams shall duly complete and submit the lists of players together with the players' identity documents to the officials of the Organiser for verification 15 minutes before the commencement of the match. Participant(s) who fail to produce valid identity documents will not be permitted to participate in the match.
- (5) 如發現機構呈交的參賽者資料與參賽者身份證上的資料不符，大會有權取消其參賽資格。
The Organiser reserves the right to disqualify a participant if there is any discrepancy between personal information shown on his/her identity document and those submitted by his/her organisation.

- (6) 未能出示有效身分證明文件的參賽者，不得出賽。
Participant(s) who fail to produce valid identity documents will not be permitted to participate in the competition(s)/event(s).

10. 棄權
Waiving of Rights

- (1) 各球員或球隊必須依照大會編定的時間出場比賽，開賽後 5 分鐘仍未能出場作賽或當比賽進行時球員不足 5 人者，作自動棄權論，賽會將判對賽隊伍勝 2-0。
Each player/team shall turn up at the scheduled time for the match. Any team that fails to turn up 5 minutes after the official commencement time or dispatches less than 5 players during the match will be regarded as having withdrawn from the match and the opponent will be judged as the winner by the Organiser at a score of 2-0.
- (2) 球隊在分組單循環制的任何一場賽事棄權後，仍可繼續參與其他賽事，棄權隊伍會被判 0-2 落敗；而在採單淘汰制的賽事中，棄權者則會被取消資格，不能繼續參與餘下的賽事，而有關成績將停留在其最後一場已參與比賽的位置。
If a team withdraws from one match under the grouped single round robin system, it can still participate in other matches. The team withdrawing from the match will be judged as the loser at a score of 0-2. For the matches adopting the single knock-out system, withdrawers will be disqualified from playing in the remaining matches. The result that the team has achieved remains at the position held by it in the last match.

11. 罰則
Penalty

- (1) 如參賽者被發現於參賽期間並非該機構的*僱員，該機構所參與的是項比賽的資格及所獲的成績將被取消。如被發現觸犯此規則超過一次，該機構所參與工商機構運動會全部比賽項目的成績及其參賽資格將被取消。所繳交的費用亦不會獲得發還。
*「僱員」的定義請參閱第 18 項附則(1)
If any participant is discovered that he/she is not the *employee of the organisation during the competition, the results achieved by the organisation in that particular competition will be cancelled. If the organisation breaches this regulation more than once, the organisation will be disqualified from taking part in this year's Corporate Games and all the entry fee will not be refunded.
*The definition of "Employee" is stated at Remarks (1) of Item No. 18.
- (2) 如有參賽者／參賽隊伍違反規則或有不良行為而影響賽事，大會有權取消其個人／有關隊伍的參賽資格，所得成績亦會作廢。
Any participant/team who violates the regulations or has any misconduct which might affect the competition, the Organiser has the right to disqualify him/her/the team from the competition and the results he/she/the team has achieved will be cancelled.
- (3) 大會有權取消嚴重犯規者的比賽資格。
The Organiser has the right to disqualify a participant who has seriously breached the regulations from the competition.
- (4) 被紅牌警告者除當場退出比賽外，下場罰自動停賽一場。
Any participant who is shown a red card will be sent off immediately and be suspended from next match automatically.
- (5) 被累積兩次黃牌警告者，下場罰自動停賽一場。
Any participant who has accumulated two yellow cards will be suspended from next match automatically.

12. 獎勵
Awards

- ： 各組別的每個項目均設冠、亞、季及殿軍獎。(各得獎隊伍必須參與最少一場賽事方可獲得獎項。)

13. 裁判
Referee : 大會將邀請資深裁判提供裁判服務。
Experienced referees will be invited to render referee services.
14. 改期
Changing the Date
of Matches : (1) 如在比賽當日，天文台於比賽當日首場賽事開始前兩小時已發出八號預警(天文台在發出八號熱帶氣旋警告信號之前兩小時內發出預警信息)、仍發出八號或以上熱帶氣旋警告信號或黑色暴雨警告信號，該日賽事即告取消。賽會稍後會通知各參賽者相應安排。
Should Pre-No.8 special announcement (an advance notice to the public issued by the Observatory when the tropical cyclone warning signal No.8 is expected within two hours), tropical cyclone warning signal No.8 or above or black rainstorm warning signal is in force 2 hours before the time scheduled for the first match on the event day, all matches on that day will be cancelled. The Organiser will notify the participants of the corresponding arrangement in due course.
(2) 若因特殊情形，大會有權通知各參賽者改期作賽或另作編排，如在比賽中發生特殊情況，繼續舉行與否得由當場裁判或大會全權決定，參賽者不得異議。
The Organiser reserves the right to postpone any match or make any alternative arrangements under special circumstances. Should anything unforeseeable happen during a match, the referee on the spot or the Organiser will decide whether the match should continue or not and participants shall not raise objection.
(3) 大會不接受參賽隊伍提議的改期申請。
No application for changing the date of any match from a participating team is accepted.
15. 上訴
Appeal : 大會不設上訴，一切賽果以當場裁判的判決為準。
No appeal will be accepted. The decisions of the referees on the spot will be final.
16. 領隊會議
Team Leaders' Meeting : 領隊會議定於 2012 年 2 月 23 日(星期四) 晚上 7 時在新界沙田排頭街 1 至 3 號康樂及文化事務署總部 1 樓視聽室進行。各參賽隊伍的領隊須親自或委派代表出席會議。由於對賽抽籤將於會上進行，沒有派代表出席的隊伍將由康樂及文化事務署職員代為抽籤，並須完全接受抽籤結果。
The team leaders' meeting will be held at 7:00 pm on 23 February 2012 (Thursday) at the Audio/Visual Room, 1/F., Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories. Team leaders of participating teams should attend or send a representative to the meeting. As the fixture draw will be held at the meeting, those teams failing to send representatives will be represented by the staff of the Leisure and Cultural Services Department in the draw and must fully accept the result of the fixture draw.
17. 裝備
Equipment : (1) 所有賽事均使用由大會提供的 4 號小型足球作賽。
Size 4 miniature footballs provided by the Organiser shall be used in all matches.
(2) 參賽者必須穿着平底膠鞋比賽，且不得穿戴有框眼鏡和任何對其他參賽者構成危險的飾物，而守門員球衣顏色應與其他參賽者和裁判的球衣顏色有顯著分別。
Participants must wear rubber and flat-soled sports shoes in match. They shall not wear rimmed spectacles or anything which is dangerous to other participants. The colour of the goalkeeper's jersey should be prominently different from that of the jerseys worn by other participants and the referee.

- (3) 球隊必須預備兩套合規格而不同顏色的號碼球衣。如兩隊球隊號碼球衣顏色相同，則按賽程編定排名較先者需更換其號碼球衣，或穿着大會供應的號碼背心。

Each team must prepare 2 sets of numbered jerseys in different colours. If two teams wear numbered jerseys of the same colour, the previous team in the competition should change their numbered jerseys, or wear the numbered vests provided by the Organiser.

18. 附則
Remarks

A participant should be an employee aged 15 or above who has been working continuously for an organisation for 4 weeks or more for at least 18 hours each week and is still being employed by the same organisation during the competition period.
