2. 參賽資格 Eligibility

Grouping

- (1) 歡迎有興趣的機構以機構/政府部門的名義參加。
 - Interested organisations in the name of organisation or the government departments are welcome to take part in the competition.
- (2) 參賽者必須年滿 15 歲,並須在有關比賽截止遞交參賽者資料日期前,已在 香港連續為參賽機構工作最少 4 星期,每星期工作最少 18 小時,而且在整 段比賽期間一直受僱於該機構。

A participant shall be 15 years of age who has been working continuously in Hong Kong for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadlines for submission of participants' particulars for the respective competitions, and is employed by the same organisation throughout the competition period.

- (3) 參賽者在整個運動會期間只可代表 1 間機構參賽。
 - A participant shall represent only 1 organisation throughout the Games.
- (4) 大會保留拒絕任何參賽者參賽的權利。

The Organiser reserves the right to forbid any participant from taking part in the competition.

6. 賽制 Format (1) 截止報名後,如有任何組別/比賽項目少於兩人/兩隊報名,該組別/比賽項目將會取消。

If the number of participant/team enrolled in any group/event is less than two after the enrolment deadline, the group/event will be cancelled.

(2) 截止報名後,如保齡球比賽的總報名人數/隊數不足總名額的一半,大會有權取消整個比賽項目。

If the total number of participants/teams in the Tenpin Bowling Competition is less than half of the overall quota after the end of the enrolment period, the Organiser has the right to cancel the competition event as a whole.

(3) 每名參賽者最多只可參加兩個項目,其中必須包括隊際項目(即參加男子 單人和隊際或女子單人和隊際)。

Each participant may participate in a maximum of two events, one of which must be a team event (i.e. Men's singles and team event or Women's singles and team event).

(4) 單人項目每名參賽者進行 3 局比賽 隊際項目每名參賽者進行 2 局比賽 (每隊 3 名參賽者)。

Singles Event: 3 games for each participant

Team Event: 2 games for each team participant (3 participants for each team)

(5) 如遇積分相同時,參賽者需再賽第九和第十格,直至分出勝負爲止。 If a tie occurs, a 9th and 10th frame roll-off will be held until the tie is broken.

- 7. 獎勵 Awards
- : 各組別的每個項目均設冠、亞、季及殿軍獎。(各得獎者/得獎隊伍必須參與賽事 方可獲得獎項。)

Prizes will be awarded to the Champion, 1st runner-up, 2nd runner-up and 3rd runner-up of each event in the respective group. (The winner/winning team must have participated in the matches in order to be awarded any prize.)

To make the competitions more interesting, an overall championship trophy will be awarded to the organisation accumulating the highest points from all events for each group. 8. 賽規 Rules (1) 所有參賽者或參賽隊伍必須在開賽前 30 分鐘,親自攜同附有相片的有效身份証明文件(正本)交予比賽幹事報到,如參賽者無法出示證件或被發現身份不符,一律不准出賽。凡於編定的比賽時間前 5 分鐘未能到場報到者,作自動棄權論。

All participant/team together with the participants' valid photo-bearing identity documents (original) shall report to the officials of the Organiser 30 minutes before the commencement of the match. Any participant who fails to produce his/her valid identify document or whose identity is not found to be matched will not be allowed to participate in the competition. Those who fail to turn up 5 minutes prior to the scheduled time for the match will be regarded as having withdrawn from the match.

(2) 各參賽者和參賽隊伍的隊長有責任核實其所得的確實分數。如核對無誤,則 比賽後須在記分紙上簽署作實。如記分紙上沒有該參賽者或隊長的簽名,大 會同樣接受,但不會接納任何有關分數的投訴。

It is the responsibility of each participant and leader of each team to verify his/her/their exact scores. If there is no mistake after verification, he/she should sign on the official score sheet. Score sheets without the signatures of the participants/leaders will also be accepted but no appeal regarding the scores will be entertained.

(3) 球道分配由大會決定,一經決定,恕不更改。

The allocation of lanes will be determined by the Organiser and no change will be made after decision.

(4) 在比賽期間,參賽者不得吸煙、喝酒或飲用含酒精的飲品。如有任何參賽者 違反此規則,大會有權終止其比賽。

During the match, the participants are not allowed to smoke, drink or take alcoholic beverages. If any participants violate this rule, the Organiser has the right to terminate his/her play in the match.

(5) 如有參賽者/參賽隊伍違反規則或有不良行為而影響賽事,大會有權取消其個人/有關隊伍的參賽資格,所得成績亦會作廢。

Any participant/team who violates the regulations or has any misconduct which might affect the competition, the Organiser has the right to disqualify him/her/the team from the competition and the results he/she/the team has achieved will be cancelled.

(6) 如參賽者/參賽隊伍未能完成所有賽事,大會將取消其個人/有關隊伍的參 賽資格,所得成績一律作廢。

If a participant/team fails to complete all matches, the Organiser will disqualify him/her/the team from the competition and the results he/she/the team has achieved will be cancelled.

(7) 除本章程明文規定外,其餘均依照香港保齡球總會的現行比賽規則辦理。 Unless explicitly stated in this prospectus, all rules and regulations will follow those presently adopted by the Hong Kong Tenpin Bowling Congress.

9. 裝備 Equipment

(1) 參賽者必須穿著合適的運動服裝及穿著襪子作賽。

Participants should put on proper sportswear and socks for competition.

- (2) 比賽場地將提供保齡球予參賽者使用,惟參賽者可自備保齡球比賽。 Bowling balls will be provided by the Organiser at competition venue. However, participants can bring their own ball for competition.
- (3) 比賽場地設有保齡球鞋租用服務,惟參賽者可自備保齡球鞋比賽。 Shoes rental service will be provided at competition venue. However, participants can bring their own shoes for competition.
- 10. 職員/參賽者須知 Notes to Staff /Participants
- (1) 成功報名的參賽機構須於 2017 年 12 月 20 日或之前於辦公時間內將抬頭為「香港特別行政區政府」的劃線支票(期票恕不接納)寄回或交回康樂及文化事務署大型活動組(地址:新界沙田排頭街1至3號康樂及文化事務署總部2樓),以辦理報名手續,並請按以下日期將「參賽者資料」及「參賽者聲明」寄回、交回或傳真(傳真號碼:26340786)至該組:
 - 2018年4月26日或之前交回「參賽者資料」
 - 2018年5月10日或之前交回「參賽者聲明」

The successfully enrolled organisations should make crossed cheques (Post-dated cheque is not accepted) payable to "The Government of the Hong Kong Special Administrative Region" and submit the cheques in person or by post to the Major Events Section of the Leisure and Cultural Services Department (Address: 2/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories) on or before 20 December 2017. They should also return the Particulars of Participants and Declaration by Participants by post, in person or by fax (Fax: 2634 0786) to the section according to the deadlines below:

- Submission of Particulars of Participants on or before 26 April 2018
- Submission of Declaration by Participants on or before 10 May 2018
- (2) 於 2018 年 5 月 10 日後,所有參賽機構均不得再更改參賽者名單。如有參加 隊際項目的參賽者辭職或受傷,而有關機構欲更改參賽者名單,便須提出書 面申請,並提交受傷參賽者的醫生證明書,大會才會因應個別情況作出考慮。 Any change of the participant list is not allowed after 10 May 2018. In case of resignation or injury of any participant in team events, application for change of the participant list will only be considered on a case by case basis provided that the application is made in a written form and attached with the medical certificate(s) of the injured person(s).
- (3) 每隊可填報年滿 18 歲的領隊/教練一名。 Each team may submit one team leader/coach aged 18 or above.
- (4) 如發現機構呈交的參賽者資料與參賽者身份證上的資料不符,大會有權取消 其參賽資格。

The Organiser reserves the right to disqualify a participant if there is any discrepancy between personal information shown on his/her identity document and those submitted by his/her organisation.

- 11. 裁判 Referee
- : 各場比賽的執法工作由合資格裁判擔任,各參賽者須服從裁判的判決。

 Judges of all matches will be served by qualified referees. All participants should abide by their decisions.

12. 上訴 Appeal

- 大會不設上訴,所有賽果以裁判最後判決為準。
 No appeal will be accepted. The referees' decision on the competition results shall be final.
- 13. 惡劣天氣安排 Inclement Weather Arrangement
- (1) 如在比賽當日,香港天文台於上午七時已發出八號預警(天文台在發出八號 熱帶氣旋警告信號之前兩小時內發出預警信息)、仍發出八號或以上熱帶氣 旋警告信號或黑色暴雨警告信號仍然生效,該日賽事即告取消。比賽將順延 至 2018 年 6 月 24 日(星期日),同時間同地點舉行。大會稍後會通知各參 賽者相應安排。

Should Pre-No.8 special announcement (an advance notice to the public issued by the Hong Kong Observatory when the tropical cyclone warning signal No. 8 is expected within two hours), tropical cyclone warning signal No. 8 or above or black rainstorm warning signal at 7am on event day, all events on that day will be cancelled and postpone to 24 June 2018 (Sunday) while the time and venue remain unchanged. The Organiser will notify the participants of the corresponding arrangement separately in due course.

When the "Air Quality Health Index (AQHI) of 7 or above" has been issued by the Environmental Protection Department on the Competition day, the arrangement of the competition as at below:

"High" health risk category (AQHI of 7)

Competition will be held as scheduled. Environmental Protection Department advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly are advised to **reduce** outdoor physical exertion, and to **reduce** the time of their stay outdoors, especially in areas with heavy traffic. Participants with existing heart or respiratory illnesses should also seek advice from a medical doctor before participating in sports activities and take more breaks during physical activities. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

「甚高」健康風險級別(空氣質素健康指數:8至10)

"Very High" health risk category (AQHI of 8-10)

Competition will be held as scheduled. Environmental Protection Department advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly to **reduce to the minimum** outdoor physical exertion, and to **reduce to the minimum** the time of their stay outdoors, especially in areas with heavy traffic. The general public is advised to **reduce** outdoor physical exertion, and to **reduce** the time of their stay outdoors, especially in areas with heavy traffic. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

"Serious" health risk category (AQHI Exceeding 10)

Competition will be held as scheduled. Environmental Protection Department advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly to **avoid** outdoor physical exertion, and to **avoid** staying outdoors, especially in areas with heavy traffic. The general public is advised to **reduce to the minimum** outdoor physical exertion, and to **reduce to the minimum** the time of their stay outdoors, especially in areas with heavy traffic. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

14. 改期 Changing the Date of Competition

- (1) 若因特殊情形,大會有權通知各參賽者改期作賽或另作編排,如在比賽中發生特殊情況,繼續舉行與否得由當場裁判或大會全權決定,參賽者不得異議。 The Organiser reserves the right to postpone any match or make any alternative arrangements under special circumstances. Should anything unforeseeable happen during a match, the referees on the spot or the Organiser will decide whether the match should continue or not and the participants shall not raise objection.
 - (2) 大會不接受參賽者/參賽隊伍提議的改期申請。
 No application for changing the date of any match from a participant/team is accepted.

15. 附則 Remarks

(1) 「僱員」的定義為該僱員須在比賽截止遞交參賽者資料日期前,已在香港連續為參賽機構工作最少4星期,每星期工作最少18小時,而且在整段比賽期間一直受僱於該機構。

The definition of "Employee" — An employee who has been working continuously in Hong Kong for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadlines for submission of participants' particulars for the competition, and is employed by the same organisation throughout the competition period.

- (2) 參賽者必須任職於有關機構為「僱員」,及年滿 15 歲。 A participant shall be an employee of the participating organisation and 15 years of age.
- (3) 為確保參賽者為參賽機構的僱員,大會在收到參賽者資料後,有權要求參賽機構於5個工作天內提交證明文件,例如有效的「僱傭合約」及強制性公積金供款紀錄,以證明參賽者為該機構的現職僱員。如未能提供有關文件,該機構的參賽資格會被取消。

To ensure all the participants are employees of the participating organisations, upon receipt of the participants' particulars, the Organiser reserves the right to request the participating organisation to produce documents such as a valid "Employment Contract" and pay-record of Mandatory Provident Fund (MPF) within 5 working days to prove that the participants are existing employees of the organisation. The organisation failing to produce such documents will be disqualified.

(4) 如大會發現任何參賽者在比賽期間並非參賽機構的僱員,該機構的參賽資格 及所得成績會被取消。如任何機構觸犯此規則多於1次,其參與「工商機構 運動會2018」的資格及全部參賽項目所得成績一律取消。已繳交的報名費概 不退還。大會有權要求該機構交還已領取的獎盃及獎牌。

If it is found that any participant is not an employee of the participating organisation during the competition, the organisation will be disqualified with its results obtained cancelled. An organisation breaches this rule more than once will be disqualified from the Corporate Games 2018 with all its results obtained from all the events cancelled. There shall be no refund of the entry fees already paid. The Organiser reserves the right to request the organisation to return the trophies and medals received.
