2. 參賽資格 Eligibility

- (1) 歡迎有興趣的機構以機構/政府部門的名義參加。
 - Interested organisations in the name of organisation or the government departments are welcome to take part in the competition.
 - (2) 參賽者必須年滿 15 歲,並須在有關比賽截止遞交參賽者資料日期前,已在 香港連續為參賽機構工作最少 4 星期,每星期工作最少 18 小時,而且在整 段比賽期間一直受僱於該機構。

A participant shall be 15 years of age who has been working continuously in Hong Kong for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadlines for submission of participants' particulars for the respective competitions, and is employed by the same organisation throughout the competition period.

- (3) 參賽者在整個運動會期間只可代表 1 間機構參賽。
 - A participant shall represent only 1 organisation throughout the Games.
- (4) 大會保留拒絕任何參賽者參賽的權利。

The Organiser reserves the right to forbid any participant from taking part in the competition.

The distance for the competition is about 7 km.

8. 賽制 Format : (1) 截止報名後,如有任何組別/比賽項目少於兩人/兩隊報名,該組別/比賽項目將會取消。

If the number of participant/team enrolled in any group/event is less than two after the enrolment deadline, the group/event will be cancelled.

(2) 截止報名後,如長跑比賽的總報名人數/隊數不足總名額的一半,大會有權取消整個比賽項目。

If the total number of participants/teams in the Distance Run Competition is less than half of the overall quota after the end of the enrolment period, the Organiser has the right to cancel the competition event as a whole.

(3) 每名參賽者的比賽成績會同時計入其個人項目和隊際項目成績內。在個人項目方面,每名參賽者只可以參加男子公開組、男子先進組或女子公開組 其中一個分組。

The result of a participant in an event will be counted as both his/her individual score and part of his/her team's score. For individual events, each participant may only enter one of the three divisions, namely Men's Open, Men's Masters or Women's Open.

(4) 個人項目:

在各項目中,最先到達終點的首四名參賽者為冠、亞、季及殿軍。 Individual Event:

In each event, the four participants who have reached the finishing line first shall be the champion, 1st runner-up, 2nd runner-up and 3rd runner-up.

(5) 隊際項目:

在各項目中,第一名到達終點者得 1 分,第二名得 2 分,第三名得 3 分,如此類推,隊際項目以每機構最快抵達終點的<u>首 5 名</u>參選賽者的總得分決定名次,分數最少的一隊為勝,如有兩隊或以上同分,則以該隊<u>第五名</u>到達終點的成員的名次定勝負。

Team Event:

In each event, the first participant who have reached the finishing line can get one point, the second one two points, the third one three points, and so on. Sum of the scores of the fastest **five participants** from an organisation who have reached the finishing line first will be counted. The champion will be the team which gets the lowest team score. If two teams or more score the same scores, the position held by the **fifth participant** of the team who has reached the finishing line will be counted.

9. 獎勵 Awards

各組別的每個項目均設冠、亞、季及殿軍獎。(各得獎者/得獎隊伍必須參與有關賽事方可獲得獎項。)

Prizes will be awarded to the Champion, 1st runner-up, 2nd runner-up and 3rd runner-up of each event in the respective group. (The winner/winning team must have participated in the matches in order to be awarded any prize.)

10. 賽規 Rules (1) 参賽者必須於比賽當日上午8時正至8時30分親自攜同附有相片的有效身份證明文件(正本)到大會「報到處」報到。參賽者於報到時將獲派發號碼布及計時晶片。如參賽者無法出示證件或被發現身份不符,一律不准出賽。開賽時間為上午9時,遲到者則會視作自動棄權論。

Participants shall report to the Registration Counter from 8:00 am to 8:30 am in the presence of valid photo-bearing identity documents (the original) for verification of identity. Each participant will be given a number cloth and timing chip. Any participant who fails to produce his/her valid identity document or whose identity is not found to be matched will not be allowed to participate in the competition. The competition will commence at 9:00 am. Latecomers will be regarded as having withdrawn from the event.

- (2) 參賽者須依照大會所定的路線進行比賽。
 - Participants must follow the route planned by the Organiser.
- (3) 如有參賽者/參賽隊伍違反規則或有不良行為而影響賽事,大會有權取消 其個人/有關隊伍的參賽資格,所得成績亦會作廢。
 - Any participant/team who violates the regulations or has any misconduct which might affect the competition, the Organiser has the right to disqualify him/her/the team from the competition and the results he/she/the team has achieved will be cancelled.
- (4) 除本章程明文規定外,其餘均依照香港業餘田徑總會的現行比賽規則辦理。 Unless explicitly stated in this prospectus, all rules and regulations will follow those presently adopted by the Hong Kong Amateur Athletic Association.

11. 裝備 Equipment (1) 參賽者必須穿着合適的運動服裝及鞋作賽。

Participants should put on proper sportswear and footwear for competition.

(2) 參賽者必須佩戴大會於比賽當日派發的號碼布,否則不准參加比賽。參賽者必須利用扣針把號碼布的四個角緊扣於胸前容易看見的位置,跑手號碼向外,切勿被遮擋,以便工作人員辨認,否則大會將保留取消其參賽資格之權利。大會不設即場補領安排,已邀交的報名費概不退還。

Participants shall wear the number cloth provided by the Organiser on the event day, otherwise they will not be permitted to participate in the competition. Participants should put their number clothes on their chest clearly visible at all time during the race to enable race officials to identify their numbers easily. Otherwise, the Organiser reserves the right to disqualify the participants concerned. No replacement will be provided by the Organiser for any lost of number cloth. There shall be no refund of the entry fees already paid.

12. 職員/參賽者須知 Notes to Staff /Participants

- (1) 成功報名的參賽機構須於 2017 年 12 月 20 日或之前於辦公時間內將抬頭為「香港特別行政區政府」的劃線支票(期票恕不接納)寄回或交回康樂及文化事務署大型活動組(地址:新界沙田排頭街 1 至 3 號康樂及文化事務署總部 2 樓),以辦理報名手續,並請按以下日期將「參賽者資料」及「參賽者聲明」寄回、交回或傳真(傳真號碼: 2634 0786)至該組:
 - 2017年12月20日或之前交回「參賽者資料」及「參賽者聲明」

The successfully enrolled organisations should make crossed cheques (Post-dated cheque is not accepted) payable to "The Government of the Hong Kong Special Administrative Region" and submit the cheques in person or by post to the Major Events Section of the Leisure and Cultural Services Department (Address: 2/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories) on or before 20 December 2017. They should also return the Particulars of Participants and Declaration by participants by post, in person or by fax (Fax: 2634 0786) to the section according to the deadlines below:

- Submission of Particulars of Participants and Declaration by Participants on or before 20 December 2017.
- (2) 於 2017 年 12 月 20 日後,所有參賽機構均不得再更改參賽者名單。 Any change of the participant list is not allowed after 20 December 2017.
- (3) 每隊可填報年滿 18 歲的領隊/教練一名。
 - Each team may submit one team leader/coach aged 18 or above.
- (4) 如發現機構呈交的參賽者資料與參賽者身份證上的資料不符,大會有權取 消其參賽資格。

The Organiser reserves the right to disqualify a participant if there is any discrepancy between personal information shown on his/her identity document and those submitted by his/her organisation.

13. 裁判 Referee : 比賽的執法工作由合資格裁判擔任,各參賽者須服從裁判的判決。
Judges will be served by qualified referees. All participants should abide by their decisions.

14. 上訴 Appeal : 大會不設上訴,所有賽果以裁判最後判決為準。

No appeal will be accepted. The referees' decision on the competition results shall be final.

15. 惡劣天氣安排 Inclement Weather Arrangement (1) 如在比賽當日,香港天文台於上午七時仍發出三號或以上熱帶氣旋警告信號、紅色或黑色暴雨警告信號,該日賽事即告取消。大會稍後會通知各參賽者相應安排。

Should the Hong Kong Observatory issue the tropical cyclone warning signal No.3 or above, red rainstorm warning signal or black rainstorm warning signal at 7 am on event day, all events on that day will be cancelled. The Organiser will notify the participants of the corresponding arrangements separately in due course.

(2) 如環境保護署於比賽當日公布的空氣質素健康指數為7級或以上,有關比賽安排如下:

When the "Air Quality Health Index (AQHI) of 7 or above" has been issued by the Environmental Protection Department on the Competition day, the arrangement of the competition as at below:

Competition will be held as scheduled. Environmental Protection Department advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly are advised to **reduce** outdoor physical exertion, and to **reduce** the time of their stay outdoors, especially in areas with heavy traffic. Participants with existing heart or respiratory illnesses should also seek advice from a medical doctor before participating in sports activities and take more breaks during physical activities. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

Environmental Protection Department advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly to **avoid** outdoor physical exertion, and to **avoid** staying outdoors, especially in areas with heavy traffic. The general public is advised to **reduce to the minimum** outdoor physical exertion, and to **reduce to the minimum** the time of their stay outdoors, especially in areas with heavy traffic. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

16. 改期 Changing the Date of Competition

(1) 若因特殊情形,大會有權通知各參賽者改期作賽或另作編排,如在比賽中 發生特殊情況,繼續舉行與否得由當場裁判或大會全權決定,參賽者不得 異議。

The Organiser reserves the right to postpone any race or make any alternative arrangements under special circumstances. Should anything unforeseeable happen during a race, the Chief Referee on the spot or the Organiser will decide whether the race should continue or not and the participants shall not raise objection.

(2) 大會不接受參賽者/參賽隊伍提議的改期申請。

No application for changing the date of any race from a participant/team is accepted.

17. 附則 Remarks

(1) 「僱員」的定義為該僱員須在比賽截止遞交參賽者資料日期前,已在香港 連續為參賽機構工作最少 4 星期,每星期工作最少 18 小時,而且在整段比 賽期間一直受僱於該機構。

The definition of "Employee" — An employee who has been working continuously in Hong Kong for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadlines for submission of participants' particulars for the competition, and is employed by the same organisation throughout the competition period.

(2) 參賽者必須任職於有關機構為「僱員」,及年滿 15 歲。

A participant shall be an employee of the participating organisation and 15 years of age.

(3) 為確保參賽者為參賽機構的僱員,大會在收到參賽者資料後,有權要求參 賽機構於5個工作天內提交證明文件,例如有效的「僱傭合約」及強制性 公積金供款紀錄,以證明參賽者為該機構的現職僱員。如未能提供有關文 件,該機構的參賽資格會被取消。

To ensure all the participants are employees of the participating organisations, upon receipt of the participants' particulars, the Organiser reserves the right to request the participating organisation to produce documents such as a valid "Employment Contract" and pay-record of Mandatory Provident Fund (MPF) within 5 working days to prove that the participants are existing employees of the organisation. The organisation failing to produce such documents will be disqualified.

(4) 如大會發現任何參賽者在比賽期間並非參賽機構的僱員,該機構的參賽資格及所得成績會被取消。如任何機構觸犯此規則多於1次,其參與「工商機構運動會2018」的資格及全部參賽項目所得成績一律取消。已繳交的報名費概不退還。大會有權要求該機構交還已領取的獎盃及獎牌。

If it is found that any participant is not an employee of the participating organisation during the competition, the organisation will be disqualified with its results obtained cancelled. An organisation breaches this rule more than once will be disqualified from the Corporate Games 2018 with all its results obtained from all the events cancelled. There shall be no refund of the entry fees already paid. The Organiser reserves the right to request the organisation to return the trophies and medals received.
