2. 參賽資格 Eligibility (1) 歡迎有興趣的機構以機構/政府部門的名義參加。

Interested organisations in the name of organisation or the government departments are welcome to take part in the competition.

(2) 參賽者必須年滿 15 歲,並須在有關比賽截止遞交參賽者資料日期前,已在 香港連續為參賽機構工作最少4星期,每星期工作最少18小時,而且在整 段比賽期間一直受僱於該機構。

9:30 am - 10:30 pm

A participant shall be 15 years of age who has been working continuously in Hong Kong for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadlines for submission of participants' particulars for the respective competitions, and is employed by the same organisation throughout the competition period.

(3) 參賽者在整個運動會期間只可代表 1 間機構參賽。

A participant shall represent only 1 organisation throughout the Games.

5. 費用 : 300 元正 Fees \$300

6. 賽制 Format : (1) 截止報名後,如有任何組別/比賽項目少於兩人/兩隊報名,該組別/比賽項目將會取消。

If the number of participant/team enrolled in any group/event is less than two after the enrolment deadline, the group/event will be cancelled.

(2) 截止報名後,如乒乓球比賽的總報名人數/隊數不足總名額的一半,大會有權取消整個比賽項目。

If the total number of participants/teams in the Table Tennis Competition is less than half of the overall quota after the end of the enrolment period, the Organiser has the right to cancel the competition event as a whole.

(3) 每名參賽者只可參加最多兩個項目,其中必須包括隊際項目(即參加單打和隊際或雙打和隊際)。

Each participant may participate in a maximum of two events, one of which must be a team event (i.e. singles and team event or doubles and team event).

(4) 所有項目均採用單淘汰制,每局 11 分。(大會有權因應報名情況而更改每項賽事的賽制)

Single knock-out system will be adopted to all events with 11 points per game. (The Organiser reserves the right to change the format of competition for each event in consideration of the enrolment situation)

- (5) 單打項目初賽和複賽採用五局三勝制;準決賽和決賽採用七局四勝制。 For singles events, the preliminary rounds and quarter-finals will adopt the best of five games system while the semi-finals and finals will adopt the best of seven games system.
- (6) 雙打項目採用五局三勝制。

For all doubles events, all matches will adopt the best of five games system.

(7) 隊際項目採用三場兩勝制,依次為男單、混雙和女單,每場賽事採用五局 三勝制。

Team event will be decided by the best of three matches system in the order of men's singles, mixed doubles and women's singles. Each match shall adopt the best of five games system.

7. 獎勵 Awards : 各組別的每個項目均設冠、亞、季及殿軍獎。(各得獎者/得獎隊伍必須參與最少一場賽事方可獲得獎項。)

Prizes will be awarded to the Champion, 1st runner-up, 2nd runner-up and 3rd runner-up of each event in the respective group. (The winner/ winning team must have played in at least one match in order to be awarded any prize.)

8. 賽規 Rules (1) 球賽開始前 15 分鐘,雙方領隊或教練須填妥出場表,各參賽者親自攜同附有相片的有效身份證明文件(正本)交予該場比賽幹事核對,如參賽者無法出示證件或被發現身份不符,一律不准出賽。各參賽者/參賽隊伍必須依照大會編定的時間出場比賽,每場賽事於裁判召集出場 5 分鐘後仍未能出場作賽或隊際比賽的參賽者仍未全部到場者,作自動棄權論。

The team leaders/coaches of both teams shall duly complete and submit the lists of participants together with the participants' valid photo-bearing identity documents (original) to the officials of the Organiser for verification 15 minutes before the commencement of the match. Any participant who fails to produce his/her valid identity document or whose identity is not found to be matched will not be allowed to participate in the competition. Each participant/team shall turn up at the scheduled time for the match. Any participant/team that fails to turn up 5 minutes after the umpires' roll call will be deemed to have abandoned their participation right.

(2) 參賽者/參賽隊伍若在賽事中棄權,會被取消參賽資格,不能繼續參與餘下賽事,其所得名次及積分會被全數取消。

If a participant/team withdraws from a match, the participant/team will be disqualified from playing in the remaining matches. All the positions obtained and points scored by the participant/ team will be cancelled.

(3) 如有參賽者/參賽隊伍違反規則或有不良行為而影響賽事,大會有權取消 其個人/有關隊伍的參賽資格,所得成績亦會作廢。

Any participant/team who violates the regulations or has any misconduct which might affect the competition, the Organiser has the right to disqualify him/her/the team from the competition and the results he/she/the team has achieved will be cancelled.

Participants should bring along their own rackets. The colour of the covering blades shall be red on one side and black on the other. The covering material of the blades shall be of a brand and type currently approved by the ITTF. (2) 比賽時參賽者必須穿著短袖球衣及不過膝短運動褲/裙(主體部分不得為 白色或類似顏色),否則大會有權拒絕該參賽者出賽。 Participants should wear a short-sleeved polo shirt, shorts/skirts (main colour of the shirt and shorts shall not be white or near to white) during the competition. The length of shorts should not exceed the knee. Otherwise, the Organiser reserves the right to disqualify the participant(s).

Participants of the same team in the doubles event and team event must wear a shirt (short-sleeved shirt) of the same colour and design. Each participant shall prepare two sets of jerseys of the same design but in significantly different colours for replacement in case competitors in the same match wear jerseys of the same colour.

(4) 參賽者必須穿着不脫色運動鞋作賽。

Participants should wear nonmarking sports shoes during the competition.

(5) 所有賽事須採用贊助商供應的「紅雙喜乒乓球,三星,型號 CF40AO/ CD40A (白色)」作為比賽指定用球。

The "DHS 3 star table tennis balls – Article No. CF40AO/ CD40A (white in colour)" provided by the sponsor shall be the official balls for the competition.

- 10. 職員/參賽者須知 Notes to Staff /Participants
- (1) 成功報名的參賽機構須於 2017年12月20日或之前於辦公時間內將抬頭為「香港特別行政區政府」的劃線支票(期票恕不接納)寄回或交回康樂及文化事務署大型活動組(地址:新界沙田排頭街1至3號康樂及文化事務署總部2樓),以辦理報名手續,並請按以下日期將「參賽者資料」及「參賽者聲明」寄回、交回或傳真(傳真號碼:26340786)至該組:

The successfully enrolled organisations should make crossed cheques (Post-dated cheque is not accepted) payable to "The Government of the Hong Kong Special Administrative Region" and submit the cheques in person or by post to the Major Events Section of the Leisure and Cultural Services Department (Address: 2/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories) on or before 20 December 2017. They should also return the Particulars of Participants and Declaration by Participants by post, in person or by fax (Fax: 2634 0786) to the section according to the deadlines below:

- Submission of Declaration by Participants on or before 30 April 2018

Any change of the participant list is not allowed after 25 April 2018. In case of resignation or injury of any participant in team events, application for change of the participant list will only be considered on a case by case basis provided that the application is made in a written form and attached with the medical certificate(s) of the injured person(s).

The Organiser reserves the right to disqualify a participant if there is any discrepancy between personal information shown on his/her identity document and those submitted by his/her organisation.

- 11. 領隊會議及對賽抽籤 Team Leaders' Meeting and Fixture Draw
- 領隊會議定於 2018 年 4 月 25 日 (星期三)晚上 7 時 30 分,在新界沙田排頭街 1 至 3 號康樂及文化事務署總部 1 樓視聽室進行,屆時將進行對賽抽籤,歡迎參賽機構派代表出席。參賽名單必須於領隊會議舉行當日或之前落實,大會於對賽抽籤後將不接納任何更改參賽名單的申請。沒有派代表出席的機構,對抽籤結果不得異議。

A team leaders' meeting and a fixture draw will be held at 7:30 pm on 25 April 2018 (Wednesday) at the Audio/Visual Room, 1/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories. Participating organisations shall send their own representative to attend. The list of participants must be confirmed on or before the date of meeting. No application for amendments to the list will be accepted after the fixture draw. Those organisations failing to send their representatives must fully accept the results as no objections shall be raised.

- 12. 裁判 Referee
- : 各場比賽的執法工作由合資格裁判擔任,各參賽者須服從裁判的判決。

 Judges of all matches will be served by qualified referees. All participants should abide by their decisions.
- 13. 上訴 Appeal

- 大會不設上訴,所有賽果以裁判最後判決為準。
 No appeal will be accepted. The referees' decision on the competition results shall be final.
- 14. 惡劣天氣安排 Inclement Weather Arrangement
- (1) 如在比賽當日,香港天文台於首場賽事/該場賽事所指定的報到時間前兩小時,已發出八號預警(天文台在發出八號熱帶氣旋警告信號之前兩小時內發出預警信息)、仍發出八號或以上熱帶氣旋警告信號或黑色暴雨警告信號仍然生效,該場賽事即告取消。大會稍後會通知各參賽者相應安排。

Should Pre-No.8 special announcement (an advance notice to the public issued by the Hong Kong Observatory when the tropical cyclone warning signal No. 8 is expected within two hours), tropical cyclone warning signal No. 8 or above or black rainstorm warning signal is in force 2 hours before the reporting time of the matches, all matches on that day will be cancelled. The Organiser will notify the participants of the corresponding arrangement separately in due course.

Competition will be held as scheduled. Environmental Protection Department advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly are advised to **reduce** outdoor physical exertion, and to **reduce** the time of their stay outdoors, especially in areas with heavy traffic. Participants with existing heart or respiratory illnesses should also seek advice from a medical doctor before participating in sports activities and take more breaks during physical activities. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

The general public is advised to **reduce** outdoor physical exertion, and to **reduce** the time of their stay outdoors, especially in areas with heavy traffic. Environmental Protection Department advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly to **avoid** outdoor physical exertion, and to **avoid** staying outdoors, especially in areas with heavy traffic. The general public is advised to **reduce to the minimum** outdoor physical exertion, and to **reduce to the minimum** the time of their stay outdoors, especially in areas with heavy traffic. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

15. 改期 Changing the Date of Competition (1) 若因特殊情形,大會有權通知各參賽者改期作賽或另作編排,如在比賽中 發生特殊情況,繼續舉行與否得由當場裁判或大會全權決定,參賽者不得 異議。

The Organiser reserves the right to postpone any match or make any alternative arrangements under special circumstances. Should anything unforeseeable happen during a match, the referee on the spot or the Organiser will decide whether the match should continue or not and the participants shall not raise objection.

No application for changing the date of any match from a participant/team is accepted.

The definition of "Employee" — An employee who has been working continuously in Hong Kong for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadlines for submission of participants' particulars for the competition, and is employed by the same organisation throughout the competition period.

(2) 參賽者必須任職於有關機構為「僱員」,及年滿 15 歲。

A participant shall be an employee of the participating organisation and 15 years of age.

(3) 為確保參賽者為參賽機構的僱員,大會在收到參賽者資料後,有權要求參 賽機構於5個工作天內提交證明文件,例如有效的「僱傭合約」及強制性 公積金供款紀錄,以證明參賽者為該機構的現職僱員。如未能提供有關文 件,該機構的參賽資格會被取消。

To ensure all the participants are employees of the participating organisations, upon receipt of the participants' particulars, the Organiser reserves the right to request the participating organisation to produce documents such as a valid "Employment Contract" and pay-record of Mandatory Provident Fund (MPF) within 5 working days to prove that the participants are existing employees of the organisation. The organisation failing to produce such documents will be disqualified.

If it is found that any participant is not an employee of the participating organisation during the competition, the organisation will be disqualified with its results obtained cancelled. An organisation breaches this rule more than once will be disqualified from the Corporate Games 2018 with all its results obtained from all the events cancelled. There shall be no refund of the entry fees already paid. The Organiser reserves the right to request the organisation to return the trophies and medals received.
