- 2. 参賽資格 Eligibility
- (1) 歡迎有興趣的機構以機構/政府部門的名義參加。
 - Interested parties are welcome to take part in the competition in the name of their organisations or government departments.
 - (2) 參賽者必須年滿 15 歲,並須在有關比賽截止遞交參賽者資料的日期前,已 連續為參賽機構工作最少 4 星期,每星期工作最少 18 小時,以及在整段比 賽期間一直受僱於該機構。

A participant shall be aged 15 or above who has been working continuously for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadline for submission of participants' particulars for the competition, and is employed by the same organisation throughout the competition period.

- (3) 參賽者在整個運動會期間只可代表 1 間機構參賽。 A participant shall represent only 1 organisation throughout the Games.
- (4) 大會保留拒絕任何參賽者參賽的權利。

The Organiser reserves the right to forbid any participant from taking part in the competition.

5. 費用 : 每間機構 600 元正 Fees \$600/each organisation

6. 賽制 Format (1) 截止報名後,如有任何組別/項目少於兩人/兩隊報名,該組別/項目將會 取消。

If the number of participants/teams enrolled in any group/event is less than 2 after the enrolment deadline, the group/event will be cancelled.

(2) 截止報名後,如羽毛球比賽的總報名人數/隊數不足總名額的一半,大會有權取消整個比賽。

If the total number of participants/teams in the Badminton Competition is less than half of the overall quota after the enrolment deadline, the Organiser has the right to cancel the whole competition.

(3) 每名參賽者只可參加最多 2 個項目,其中必須包括隊際項目(即 1 項單打和 1 項隊際或 1 項雙打和 1 項隊際)。

Each participant may participate in a maximum of 2 events, one of which must be a Team Event (i.e. either 1 Singles and 1 Team Event, or 1 doubles and 1 Team Event).

(4) 所有項目均採用單淘汰制。(大會有權因應報名情況而更改每項賽事的賽制。)

A single knock-out system will be adopted for all events. (The Organiser has the right to change the format of the competition for each event in view of the enrolment response.)

(5) 單打和雙打項目的所有賽事均採用國際羽毛球聯會現行的「21分3局2勝直接得分制」。

For Singles and Doubles Events, the Rally Points Scoring System (a match consisting of the best of 3 games of 21 points) currently adopted by the International Badminton Federation (IBF) will be applied to all matches.

(6) 隊際項目採用 3 場 2 勝制,比賽次序為男單、混雙和女單。隊際項目的所有 賽事均採用國際羽毛球聯會現行的「21 分 3 局 2 勝直接得分制」。

Team Events will be decided by the "best of 3 matches" system in the order of men's singles, mixed doubles and women's singles. The Rally Points Scoring System (a match consisting of the best of 3 games of 21 points) currently adopted by the IBF will be applied to all matches of Team Events.

7. 獎勵 Awards 各組別的每個項目均設冠、亞及季軍(得獎者/得獎隊伍必須參與最少1場賽事方可獲得獎項)。

Prizes will be awarded to the Champion, 1st runner-up and 2nd runner-up of each event in the respective groups (the winner/winning team must have played in at least 1 match in order to be awarded any prize.)

To make the competitions more interesting, an overall championship trophy will be awarded to the organisation accumulating the highest points from all events for each group. 8. 賽規 Rules (1) 球賽開始前 15 分鐘,雙方領隊、教練或隊長須填妥出場表交到報到處。 各參賽者亦須親自攜同附有相片的有效身份證明文件正本(例如:香港永久 性居民身份證、香港居民身份證)到報到處報到,如無法出示證件或被發現 身份不符,一律不准出賽,以及不得換人補上。各參賽者/隊伍必須依照大 會編定的時間出場比賽。每場賽事於裁判召集出場後 5 分鐘內仍未能出場或 隊際比賽的參賽人數不足,將作棄權論。

The team leaders/coaches/captains of both teams shall duly complete and submit the lists of participants to the registration counter 15 minutes before the commencement of the match. All participants shall report to the registration counter in person with the originals of their valid photo-bearing identity documents (e.g. Hong Kong Permanent Identity Card, Hong Kong Identity Card). Any participant who fails to produce his/her valid identity document or whose identity is found unmatched will not be allowed to participate in the competition and no replacement of athletes will be allowed. Each participant/team shall turn up at the scheduled time for the match. If a participant fails to turn up / a team fails to turn up in full team within 5 minutes after the roll call made by the umpire, the participant/team will be regarded as having withdrawn from the event.

- (2) 參賽者/隊伍若在賽事中棄權,會被取消參賽資格,不能參與餘下的賽事, 其所得名次及積分會被全數取消,惟以下情況除外:
 - 進入4強賽至決賽的參賽者/隊伍如因傷病或公事未能參與賽事,但能提供分別由註冊醫生或該機構簽署的相關證明文件,其在最後一場賽事所得的名次和積分可獲保留。該隊領隊/教練/聯絡人必須於賽事開始前或該參賽者/隊伍缺席賽事後2個工作天內向大會提供有關證明文件,逾時提交者作棄權論。

If a participant/team withdraws from a match, he/she/the team will be disqualified from playing in the remaining matches. All positions obtained and points scored by the participant/team will be cancelled except in the following circumstance.

If a participant/team fails to turn up in the semi-final and final due to injury/illness or other engagements, the positions the participant/team obtained and the points he/she/the team scored in the last match will be retained if he/she/the team can produce relevant supporting documents issued by registered medical practitioners or the organisation. The team leader/coach/contact person is required to provide the relevant supporting documents before the start of the match or within 2 working days after the match from which the participant/team is absent. The participant/team who is late in submitting the supporting documents will be regarded as having withdrawn from the event.

(3) 參賽者/隊伍如違反規則或有不良行為而影響賽事,大會有權取消其個人/ 隊伍的參賽資格,所得成績亦會作廢。

The Organiser has the right to disqualify any participant/team that violates the regulations or commits misconduct which may affect the competition, and the results he/she/the team has achieved will be cancelled.

(4) 除本章程明文規定外,其餘均依照中國香港羽毛球總會的現行比賽規則辦理。

Unless explicitly stated in this prospectus, all rules and regulations will follow those presently adopted by the Badminton Association of Hong Kong, China.

- 9. 裝備 Equipment
- : (1) 參賽者必須穿着適當的羽毛球服裝及不脫色運動鞋,以及自備球拍作賽。
 Participants should wear proper badminton attire and non-marking sports shoes and use their own rackets during the competition.
 - (2) 所有賽事採用大會供應的羽毛球作賽。 Shuttlecocks provided by the Organiser shall be used in all matches.
- 10. 職員/參賽者須知 Notes to Staff / Participants
- (1) 成功報名的參賽機構須於 2025 年 2 月 13 日 (星期四)或之前將抬頭為「香港特別行政區政府」的劃線支票(期票恕不接納)郵寄或於辦公時間內遞交至康樂及文化事務署大型活動組(地址:新界沙田排頭街 1 至 3 號康樂及文化事務署總部 2 樓),以辦理報名手續,並請按以下日期將「參賽者資料」以及「年滿十八歲的參賽者聲明」及/或「未滿十八歲的參賽者聲明」寄回、交回或傳真(傳真號碼: 2634 0786)至該組:
 - 2025年4月7日(星期一)或之前交回「參賽者資料」
 - 2025年4月16日(星期三)或之前交回「年滿十八歲的參賽者聲明」 及/或「未滿十八歲的參賽者聲明」

Organisations which have successfully enrolled in the competition should make crossed cheques (post-dated cheque is not accepted) payable to "The Government of the Hong Kong Special Administrative Region" and submit the cheques by post or in person to the Major Events Section of the Leisure and Cultural Services Department (Address: 2/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories) during office hours on or before 13 February 2025 (Thursday). "Particulars of Participants", "Declaration by Participants Aged 18 or above" and/or "Declaration by Participants Aged below 18" should be returned by post, in person or by fax (Fax No.: 2634 0786) to the section according to the deadlines below:

- Submission of "Particulars of Participants" on or before 7 April 2025 (Monday)
- Submission of "Declaration by Participants Aged 18 or above" and/or "Declaration by Participants Aged below 18" on or before 16 April 2025 (Wednesday)
- (2) 於 2025 年 4 月 16 日 (星期三)後,所有參賽機構均不得再更改參賽者名單。 如有隊際項目的參賽者辭職或受傷,而有關機構欲更改參賽者名單,須盡快 於辦公時間內向大會提出書面申請,並提交受傷參賽者的醫生證明書或有關 機構認可的證明,大會才會因應個別情況作出考慮。

Any change of the list of participants is not allowed after 16 April 2025 (Wednesday). In case of resignation or injury of any participant in Team Events, application for change of the list will only be considered on a case-by-case basis provided that the application is made in a written form within the office hours to the Organiser as soon as possible and attached with the medical certificate(s) of the injured person(s) or approved document issued by the organisation.

- (3) 每隊可填報一名年滿 18 歲的領隊/教練。 Each team may nominate one team leader/coach aged 18 or above.
- (4) 如發現機構呈交的參賽者資料與參賽者身份證上的資料不符,大會有權取消 其參賽資格。

The Organiser reserves the right to disqualify a participant if there is any discrepancy between personal information shown on his/her identity document and that submitted by his/her organisation.

11. 領隊會議及對賽抽籤 Team Leaders' Meeting and Fixture Draw : 領隊會議將於 2025 年 4 月 16 日(星期三)晚上 7 時在新界沙田排頭街 1 至 3 號 康樂及文化事務署總部 1 樓視聽室舉行,屆時將進行對賽抽籤,各參賽機構須派 代表出席。參賽者名單必須於領隊會議舉行當日或之前落實,大會於對賽抽籤後 將不接納任何更改參賽者名單的申請。沒有派代表出席的機構,對抽籤結果不得 異議。

A team leaders' meeting and a fixture draw will be held at 7:00 pm on 16 April 2025 (Wednesday) at the Audio/Visual Room, 1/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories. Participating organisations shall send their representatives to attend. The list of participants must be confirmed on or before the date of meeting. No application for amendments to the list will be accepted after the fixture draw. Organisations failing to send their representatives must fully accept the results of the fixture draw without objection.

- 12. 裁判 Referee
- : 各場比賽的執法工作由合資格裁判擔任,參賽者須服從裁判的判決。

 Judges of all matches will be served by qualified referees. All participants should abide by their decisions.

13. 上訴 Appeal

- : 大會不設上訴,所有賽果以裁判最後判決為準。
 No appeal will be accepted. The referees' decision on the competition results shall be final.
- 14. 惡劣天氣安排 Inclement Weather Arrangement
- (1) 如在比賽當日,第一輪賽事報到時間前2小時,香港天文台發出8號熱帶氣旋警告信號預警,或8號或以上熱帶氣旋警告信號或黑色暴雨警告信號仍然 生效,該日賽事即告取消。大會稍後會通知各參賽者相應安排。

If the Pre-No.8 Special Announcement has been issued by the Hong Kong Observatory 2 hours before the reporting time for the first round of matches on the competition day, or the Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal is still in force, all matches on that day will be cancelled. The Organiser will notify the participants of the corresponding arrangement separately in due course.

(2) 如環境保護署(環保署)於比賽當日公布的空氣質素健康指數為7級或以上,有關比賽安排如下:

When the "Air Quality Health Index (AQHI) of 7 or above" has been issued by the Environmental Protection Department (EPD) on the competition day, the arrangement of the competition is as follows:

"High" health risk category (AQHI of 7)

Competition will be held as scheduled. The EPD advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly to **reduce** outdoor physical exertion, and to **reduce** the time of their stay outdoors, especially in areas with heavy traffic. Participants with existing heart or respiratory illnesses should also seek advice from a medical doctor before participating in sports activities and take more breaks during physical activities. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

Competition will be held as scheduled. The general public is advised to reduce outdoor physical exertion, and to reduce the time of their stay outdoors, especially in areas with heavy traffic. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

The EPD advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly to **avoid** outdoor physical exertion, and to **avoid** staying outdoors, especially in areas with heavy traffic. The general public is advised to **reduce to the minimum** outdoor physical exertion, and to **reduce to the minimum** the time of their stay outdoors, especially in areas with heavy traffic. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

15. 改期 Changing the Date of Competition

- (1) 大會有權因應特殊情況改期作賽或另作安排。如在比賽中出現突發情況,得由當場裁判或大會全權決定是否繼續舉行比賽,參賽者不得異議。
 - The Organiser reserves the right to change the date of a competition or make any alternative arrangements under special circumstances. Should anything unforeseeable happen during the competition, the referee on the spot or the Organiser has full discretion about whether the competition should continue and participants shall raise no objection.

 - For a participant/team who has already taken part in one of the events or the preliminary round during the competition, if the participant/team cannot participate in the remaining matches due to inclement weather or any other reasons, there shall be no refund of the entry fee.
- (3) 大會不接受參賽者/隊伍的改期申請。

No application for changing the date of any competition from a participant/team is accepted.

16. 附則 Remarks The definition of "employee" — An employee who has been working continuously for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadline for submission of participants' particulars for the competition, and is employed by the same organisation throughout the competition period.

- (2) 参賽者必須任職於有關機構為「僱員」,及年滿 15 歲。 A participant shall be an employee of the participating organisation and aged 15 or above.
- (3) 為確保參賽者為參賽機構的僱員,大會有權要求參賽機構於5個工作天內出 示有效的「僱傭合約」及強制性公積金供款紀錄,以證明參賽者為該機構的 現職僱員。參賽機構須於報名前得到參賽者同意提供「僱傭合約」及強制性 公積金供款紀錄予大會核查其僱員身份。如未能提供有關文件,該機構的參 賽資格會被取消,已繳交的報名費概不退還。

To ensure all the participants are employees of the participating organisation, the Organiser reserves the right to request the participating organisations to produce valid employment contracts and contribution records of Mandatory Provident Fund (MPF) within 5 working days to prove that the participants are existing employees of the organisation. Participating organisations are required to obtain the participants' consent to provide employment contracts and contribution records of MPF to the Organiser for verification of their employee status before registration. Organisations failing to produce such documents will be disqualified from the competition and there shall be no refund of the entry fees already paid.

 Participants shall comply with all the rules and regulations prescribed by the competition venue and the announcements of the Organiser.
