Reply:

1. & 2. It was announced in the 2019 Policy Address that the Government would launch a five-year plan to transform more than 170 public play spaces (PPSs) under the Leisure and Cultural Services Department (LCSD) across the territory, with a view to offering the play spaces with different degrees of challenges and fun. The total estimated expenditure for the entire plan is \$686 million, including the costs of preliminary investigation of underground public utilities and engaging professional companies for projects, as well as the staff remuneration and recurrent expenditures of the LCSD

and Architectural Services Department. Such being the case, a breakdown for the expenditure on the PPSs projects is not available.

The LCSD has launched 87 PPSs transformation projects with details tabulated at <u>Annex I</u>. More than 80 of the remaining projects are in the pipeline, with the list of PPSs to be transformed subject to consultation with the District Councils. The Department anticipates that over 170 projects can be launched as planned by 2025.

The first 4 small sized PPS venues are open for public use upon completion of transformation works, with details tabulated below:
