Question:

In connection with the feeder systems for identification and development of young potential athletes, would the Government advise this Committee of the following:

- 1. Regarding the implementation of the feeder systems over the previous year, what was the expenditure earmarked in the estimates for individual "national sports associations" (NSAs) and how effective was the work? What are the mechanism and criteria adopted by the Government to assess the effectiveness of the provision? What is the estimated expenditure for individual NSAs this year? What is the specific work plan?
- 2. Apart from supporting the NSAs, what measures are put in place by the Government to support the implementation of the feeder systems for other sports? What are the estimated expenditures involved?
- 3. How many schools participated in the Student Athlete Support Scheme (the Scheme) in the previous year? How many student athletes have benefited from the Scheme? What was the expenditure involved?

Reply:

 & 2. The Leisure and Cultural Services Department (LCSD)'s provision for implementing the Feeder System Scheme (FSS) in 2022-23 amounted to \$37.1 million for supporting feeder programmes organised by 53 national sports associations (NSAs). The subvention granted to each NSA is at <u>Annex</u>. The work related to the feeder system includes the implementation of development programmes, talent identification, regional and junior squad training, organisation of local competitions, as well as sending of squads to overseas training and competitions. The LCSD assesses the effectiveness of the FSS by monitoring the achievement of performance targets set by the NSAs, including the organisation of feeder programmes, recruitment of squad members, and athletes' achievements in international sports competitions. Since its launch in 2009-10, the FSS has achieved notable results. As at December 2022, the FSS has resulted in the identification of 5 806 athletes for promotion to higher level squads for further training. Of these, 1 149 have managed to join junior squads of different sports. The LCSD will continue to monitor the effectiveness of the FSS.

In 2023-24, the LCSD will earmark a funding of around \$38.7 million in total to support the NSAs in implementing feeder programmes. The amount to be allocated to the individual NSAs is subject to confirmation.

3. In the 2021/22 school year, a total of 594 primary and secondary schools signed up for the Student Athlete Support Scheme. The total number of students benefiting from the Scheme was 14 194, involving a funding of about \$5.96 million.
