(II) Camp Rules

- 1. Follow the rules and instructions given by the Music Office staff and arrive at the training venue 15 minutes before rehearsal.
- 2. Rehearsals are not open to the public.
- 3. No eating or drinking is allowed during rehearsals.
- 4. Campers must abide by the "Precautionary Measures to Prevent COVID-19 and Other Communicable Epidemic Diseases" as set by the Music Office (Please refer to Part VI).
- 5. The Chief Music Officer reserves the right to update the camp rules and make the final decision on any dispute.

B. 1/8 (Sun):

If Tropical Cyclone Warning Signal No. 3 is issued on the day of the Music Camp Concert, i.e. 1/8 (Sunday), but the Hong Kong Observatory has not indicated that Tropical Cyclone Warning Signal No. 8 or above is expected in the afternoon, campers should rehearse and perform on that day, and report to the orchestra/ ensemble manager at the Hong Kong City Hall Concert Hall at the time specified in Part (III). If the Red or Black Rainstorm Warning Signal is issued on 1/8 (Sunday), the Chief Music Officer will exercise discretion to decide whether rehearsal/ performance will continue, taking into consideration campers' safety. Parents/ guardians will be notified through Short Message Service (SMS) as soon as possible.

(V) Leave Application Procedures

- 1. Campers must attend all rehearsals. Any leave must be approved by the Music Office in advance.
- 2. Leave application procedures are as follows:

Campers aged under 18

- i. A duly completed application form ⁽⁶⁾ countersigned by a parent/ guardian is required.
- ii. The duly completed application form for leave has to be submitted to the orchestra/ ensemble manager to process.

Campers aged 18 or above

- i. Campers shall notify their parents in advance, and submit a duly completed application form to the orchestra/ ensemble manager to process.
- 3. For campers aged under 18, who are granted approval for leave, their parents/ guardians shall be responsible for their children's off-site safety as well as transportation arrangements.
- 4. The Leisure and Cultural Services Department shall not be liable for the safety of campers during their absence.
- 5. For campers who have a record of leave on more than two occasions or absence from rehearsal for more than seven hours, attendance certificates for the Music Camp will not be issued.
- 6. Any fee paid will not be refunded for campers who are approved to cease training for personal reasons.
- (6) The leave application form can be obtained from the orchestra/ ensemble manager.

(VI) Precautionary Measures to Prevent COVID-19 and Other Communicable Epidemic Diseases

- 1. To safeguard the health of campers, campers must comply with the following:
 - i. Bring along face masks (suggested at least 2 pieces per day) and disinfectant alcohol towels or alcohol spray/ gel;
 - ii. Hand in the completed "Travel and Health Declaration and Undertaking" (Appendix 3) to the orchestra/ ensemble manager on the first day of the music camp. (Note: campers should not return to the training venue if they are still under compulsory quarantine of 14 or 21 days);
 - iii. Wear your own masks before entering the music centre and during training;
 - iv. Disinfect your hands with an alcohol-based hand-rub before training. Clean the seats, music stands, shared musical instruments, and partitions with disinfectant tissues provided by the Music Office before and after training;
 - v. If you experience physical discomfort, including fever, diarrhea, vomiting, red eyes, rash, sore throat, cough, shortness of breath, fatigue, loss of taste or smell, or other symptoms of upper respiratory tract infection, please do not attend the training and seek medical advice as soon as possible;
 - vi. If you are tested positive for COVID-19 or are defined by the Department of Health as a "close contact" of a confirmed case of COVID-19, or if there is a confirmed case in your school or building, the orchestra/ ensemble manager of the music camp must be notified immediately.
 - vii. Campers are required to scan the "LeaveHomeSafe" QR code or register their name, contact number and the date and time of the visit before entering the music centre. Please arrive earlier to avoid delaying the training activities.
- 2. Campers must undergo a temperature check before training. In case of fever (above 99.5°F or 37.5°C), campers must stop the training in the music camp. They are only allowed to resume the remaining activities after full recovery certified by a doctor.
- 3. All people should try to keep a distance of at least 1.5 metres. Parents or guardians should leave immediately after dropping off or picking up campers to avoid crowd gathering at music centres.
- 4. The Music Office has hired professional companies to conduct comprehensive cleaning and photo-catalytic disinfection of training sites, and will continue to perform regular cleaning and disinfection following the guidelines of the Department of Health to ensure the hygiene of the venues.
- 5. According to the "Guidelines on Prevention of Communicable Diseases" issued by the Centre for Health Protection of the Department of Health, if campers suffer from COVID-19, influenza or respiratory tract infections within a short period, the Music Office has to report to the Department of Health and takes measures to prevent the spread of diseases. Campers are required to comply with the directive of the Music Office to stop the training and leave the camp. Any fee paid will not be refunded.

(VII) Others

- 1. The Music Office reserves the right to change the programme and training arrangements.
- 2. The Music Office shall have the absolute discretion to use any photographs, videos, or any other record of the music camp training and concert for any lawful purposes including but not limited to archiving, advertising, and promotion.
