# Recruitment for 2022/23 Band/Choir/Orchestra Members

The 18 Music Office bands/orchestras and two choirs, trained by Music Office instructors, provide different levels of ensemble training for young musicians aged 25 or under. Rehearsals are conducted once a week, with other arrangements like online training made under special circumstances. Details on rehearsal time & venue are listed in the following pages.

In addition to regular rehearsals, the 20 bands/choirs/orchestras will also have opportunities to perform and participate in various cultural activities and music exchanges with visiting young musicians from the Mainland and overseas. Outstanding members might be recommended for enrolment in the Music Office Instrumental Music Training Scheme. Training for 2022-23 will commence in September 2022 and conclude in May 2023.

## **Entry Requirements and Fees**

Entry requirements for the respective bands/choirs/orchestras are detailed in the following pages. Training is free of charge, but members are required to bring their own instruments (except for bulky instruments) and purchase uniforms and necessary music scores at their own expense.

# **Application Method**

- 1. **By post / in person**: The completed application form, together with (i) supporting proofs of standard eg. copies of exam results or instructor's recommendation or testimonial, which indicates applicants who have attained the required standard of the applied Course (Applications without supporting proofs will not be considered), (ii) 2 self-addressed envelopes\* with sufficient postage should be sent by post or submitted in person **to the training centre of the selected band/choir/orchestra** (1) on or before 16 May 2022, with name of band/choir/orchestra clearly marked on the envelope.
  - \* As applicants who have provided an email address on the application form will receive all notifications by email, there is no need for them to enclose any self-addressed envelopes in their applications.
- 2. **Online application**: Applications should be submitted through the Music Office online application system (www.lscd.gov.hk/musicoffice) on or before 16 May 2022. Applicants will receive an acknowledgement of receipt together with an application number upon completion of the online application. The same acknowledgement of receipt will also be emailed to the applicant thereafter (Please check all mailboxes, including inbox, junk and spam mail to avoid misdeliveries). Applicants who have not received the acknowledgement receipt should consider their application unsuccessful and submit a new application. In case of doubt, they can email their selected band/choir/orchestra(1) on the next working day.
- 3. Qualified applicants who have not received the audition notification pertaining to their submission of the audition video by 23 May 2022 should email their selected band/choir/orchestra. [Audition Content: the performance of a self-chosen work of meeting the stated standard / and designated pieces / excerpts for the selected band/choir/orchestra]. Deadline for submission is 12 June 2022. Late submission will not be considered.
- 4. Current members must also re-apply.
- 5. Applicants will be notified of the results of their applications by mid-August 2022.
- 6. Each applicant should submit only 1 application (whether by post, in person or online), otherwise, he/she will be disqualified.
