2. 參賽資格  
Eligibility

- ：
- (1) 歡迎有興趣的工商機構(如有需要,大會有關要求報名機構提供有關證明,如有效的香港商業登記證)和政府部門以總公司/政府部門的名義參加。  
Interested organisations (may be required to produce relevant supporting documents such as Business Registration Certificate) in the name of head office and the government departments are welcome to take part in the competition.
  - (2) 參賽者必須任職於該機構,年滿 15 歲並已為同一僱主連續工作 4 星期或以上,而每星期最少工作 18 小時,並在比賽進行期間,仍然受僱於該機構。  
A participant should be an employee aged 15 or above who has been working continuously for an organisation for 4 weeks or more, for at least 18 hours each week and is still being employed by the same organisation during the competition period.
  - (3) 參賽者只能代表一間機構,如轉換代表機構,參賽者必須已離開前任職機構,並在該項比賽首場賽事進行時已在新代表的機構連續工作 4 星期或以上,而每星期最少工作 18 小時,並在比賽進行期間,仍然受僱於該機構。

Each participant can only represent one organisation. A participant may represent another organisation provided that he/she has resigned from the previous organisation and has been working continuously for the current organisation for not less than 4 weeks when the first match of the competition takes place, for at least 18 hours each week and is still being employed by the organisation during the competition period.

5. 費用 Fees : 500 元正 \$500

6. 賽制 Format :
- (1) 在截止報名後，如有任何組別／比賽項目少於兩隊報名，該組別／賽事將會取消。

If the number of team enrolled in any group/event is less than two after the enrolment deadline, the group/event will be cancelled.

- (2) 男子甲、乙組初賽採分組單循環制，以 4 隊為一組，每組首名出線。出線隊伍再採分組單循環制進行複賽，以 3 隊為一組，每組首名出線。出線隊伍再採單淘汰制進行比賽。

男子丙組和女子甲、乙、丙組初賽均採分組單循環制，以 4 隊為一組，每組首名出線。出線隊伍再採單淘汰制進行比賽。

(大會有關因應報名情況而更改每項賽事的賽制。)

For Groups A and B of the Men's Division, a single round robin system on group basis will be adopted in the preliminary round. Each group will consist of 4 teams. A single round robin system on group basis will be applied to matches among each group's top team in the second round. Each group will consist of 3 teams in this round. Single knock-out system will be applied to matches among each group's top team.

For Group C of the Men's Division and Groups A, B and C of the Women's Division, a single round robin system on group basis will be adopted in the preliminary round. Each group will consist of 4 teams. Single knock-out system will be applied to matches among each group's top team.

(The Organiser reserves the right to change the format of competition for each event in consideration of the enrolment situation.)

- (3) 初賽分組編排由大會抽籤決定。

Grouping for matches in the preliminary round will be decided through lots drawing by the Organiser.

- (4) 全場比賽時間為 40 分鐘，共分 4 節，每節為 10 分鐘。第一節與第二節比賽和第三節與第四節比賽的休息時間為 1 分鐘，半場(第二節與第三節比賽)休息時間為 5 分鐘，各組賽事的休息時間將按「香港籃球總會」的規定暫停比賽計時鐘。

The duration of each match will be 40 minutes. The game shall consist of 4 periods of 10 minutes each. There will be intervals of 1 minute between the first and second periods, and between the third and fourth periods. The half-time interval (i.e. between the second and third periods) is 5 minutes. The game clock will be stopped according to the Rules and Regulations of the Hong Kong Basketball Association.

- (5) 如在法定時間賽和，加時 5 分鐘；再和，則每隊指派 5 名球員互射罰球，採用「即時死亡」制決定勝負。

If the match ends in a draw within the normal playing time, there will be an extra period of 5 minutes. If the match still ends in a draw after the extra time, 5 players of each team should be assigned to shoot a free throw at the penalty line and the “sudden death” rule will be adopted.

7. 計分法  
Point Scoring System

- (1) 在單循環制賽事中，每場勝方得 2 分，負方得 1 分，而棄權得 0 分。棄權隊伍作 0:20 落敗論。

In matches adopting the single round robin system, the winner gains 2 points and the loser gains 1 point. The withdrawer gains no points and will be taken as being defeated in the match by 0:20.

- (2) 在單循環制賽事中，如兩隊積分相同，則以該兩隊對賽成績勝者為勝，若同分者超過兩隊，則以有關隊伍的相關比賽得失球差額以決定勝負；若未分出勝負，則以全部比賽總得失球差額決定名次。如仍然相同，則以抽籤決定名次。

In matches adopting the single round robin system, if two teams score the same points, the winner will be the win side of the match between the two teams. If more than 2 teams score equal points, the winner will be determined by the goal differences of the respective matches played by the teams involved. If the tie persists, the ranking will be determined by the goal differences of all matches. If the scores are still equal, ranking will be decided by lots drawing.

8. 賽則  
Rules

- ：除本章程明文規定外，其餘均依照香港籃球總會的現行比賽規則辦理。

Unless explicitly stated in this prospectus, all rules and regulations will follow those presently adopted by the Hong Kong Basketball Association.

9. 職員／參賽者須知  
Notes to Staff /Participants

- (1) 成功報名的參賽機構須於 2012 年 2 月 10 日或之前於辦公時間內將抬頭為「香港特別行政區政府」的支票寄回或交回康樂及文化事務署大型活動組(地址：新界沙田排頭街 1 至 3 號康樂及文化事務署總部 2 樓)，以辦理報名手續，並請按以下日期將「參賽者資料」及「參賽者聲明」寄回、交回或傳真(傳真號碼：2634 0786)至該組：

- 2012 年 5 月 24 日或以前交回「參賽者資料」
- 2012 年 6 月 14 日或以前交回「參賽者聲明」

The successfully enrolled organisations should make crossed cheques payable to “The Government of the Hong Kong Special Administrative Region” and submit the cheques in person or by mail to the Major Events Section of the Leisure and Cultural Services Department (Address: 2/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories) on or before 10 February 2012. They should also return the Particulars of Participants and Declaration by participants by mail, in person or by fax (Fax: 2634 0786) to the section according to the deadline below:

- Submission of Particulars of Participants on or before 24 May 2012
- Submission of Declaration by Participants on or before 14 June 2012

- (2) 每隊可填報領隊／教練一名及球員 15 名。

Each team can submit a list of one team leader / coach and 15 players.

- (3) 於 2012 年 6 月 18 日後，所有參賽隊伍均不得再改動隊員名單。如有隊員辭職或受傷，而有關機構欲改動隊員名單，便須提出書面申請，並提交受傷隊員的醫生證明書，大會才會因應個別情況作出考慮。

Any change of team members is not allowed after 18 June 2012. In case of resignation or injury of any team member, application for change of team members will only be considered on a case by case basis provided that the application is made in a written form and attached with the medical certificate(s) of the injured person(s).

- (4) 球賽開始前 20 分鐘，雙方領隊或教練須填妥出場表，連同球員的身分證明文件交予該場比賽幹事核對，未能出示有效身分證明文件的球員，不得出賽。

The team leaders/coaches of both teams shall duly complete and submit the lists of players together with the players' identity documents to the officials of the Organiser for verification 20 minutes before the commencement of the match. Participant(s) who fail to produce valid identity documents will not be permitted to participate in the match.

- (5) 如發現機構呈交的參賽者資料與參賽者身份證上的資料不符，大會有權取消其參賽資格。

The Organiser reserves the right to disqualify a participant if there is any discrepancy between personal information shown on his/her identity document and those submitted by his/her organisation.

- (6) 未能出示有效身分證明文件的參賽者，不得出賽。

Participant(s) who fail to produce valid identity documents will not be permitted to participate in the match.

10. 棄權  
Waiving of Rights

- (1) 各球員或球隊必須依照大會編定的時間出場比賽，開賽後 5 分鐘仍未能出場作賽或當比賽進行時球員不足 5 人者，作自動棄權論，賽會將判對賽隊伍獲勝。

Each player/team shall turn up at the scheduled time for the match. Any team that fails to turn up 5 minutes after the official commencement time or dispatches less than 5 players during the match will be regarded as having withdrawn from the match and the opponent will be judged as the winner by the Organiser.

- (2) 如球隊在比賽中途擅自離場，經裁判向賽會報告後，判作棄權論，賽會將判對賽隊伍獲勝。

If the team leaves the court without notification in advance, upon the report to the Organiser by the referee, the team will be regarded as having withdrawn from the match and the opponent will be judged as the winner.

- (3) 球隊在分組單循環制的任何一場賽事棄權後，仍可繼續參與其他賽事；而在採單淘汰制的賽事中，棄權者則會被取消資格，不能繼續參與餘下的賽事，而有關成績將停留在其最後一場已參與比賽的位置。

If a team withdraws from one match under the grouped single round robin system, it can still participate in other matches. For the matches adopting the single knock-out system, withdrawers will be disqualified from playing in the remaining matches. The result that the team has achieved remains at the position held by it in the last match.

11. 罰則  
Penalty

- (1) 如參賽者被發現於參賽期間並非該機構的\*僱員，該機構所參與的是項比賽的資格及所獲的成績將被取消。如被發現觸犯此規則超過一次，該機構所參與工商機構運動會全部比賽項目的成績及其參賽資格將被取消。所繳交的費用亦不會獲得發還。

\*「僱員」的定義請參閱第 18 項附則(1)

If any participant is discovered that he/she is not the \*employee of the organisation during the competition, the results achieved by the organisation in that particular competition will be cancelled. If the organisation breaches this regulation more than once, the organisation will be disqualified from taking part in this year's Corporate Games and all the entry fee will not be refunded.

\*The definition of "Employee" is stated at Remarks (1) of Item No. 18.

- (2) 如有參賽者／參賽隊伍違反規則或有不良行為而影響賽事，大會有權取消其個人／有關隊伍的參賽資格，所得成績亦會作廢。

Any participant/team who violates the regulations or has any misconduct which might affect the competition, the Organiser has the right to disqualify him/her/the team from the competition and the results he/she/the team has achieved will be cancelled.

- (3) 球員在賽事中，如被裁判判處奪權犯規（判罰離場），除即時自動停賽一場外，大會仍保留進一步處罰的權利。

If any player is punished to leave the court, he/she will be suspended from playing in the match immediately. The Organiser will reserve the right to impose further penalty.

12. 獎勵  
Awards
- : 各組別的每個項目均設冠、亞、季及殿軍獎。(各得獎隊伍必須參與最少一場賽事方可獲得獎項。)

13. 裁判  
Referee
- : 大會將邀請香港籃球總會提供裁判服務。  
Hong Kong Basketball Association will be invited to render referee services.
14. 改期  
Changing the Date of  
Matches
- : (1) 如在比賽當日，天文台於比賽當日首場賽事開始前兩小時已發出八號預警(天文台在發出八號熱帶氣旋警告信號之前兩小時內發出預警信息)、仍發出八號或以上熱帶氣旋警告信號或黑色暴雨警告信號，該日賽事即告取消。賽會稍後會通知各參賽者相應安排。  
Should Pre-No.8 special announcement (an advance notice to the public issued by the Observatory when the tropical cyclone warning signal No.8 is expected within two hours), tropical cyclone warning signal No.8 or above or black rainstorm warning signal is in force 2 hours before the time scheduled for the first match on the event day, all matches on that day will be cancelled. The Organiser will notify the participants of the corresponding arrangement in due course.
- (2) 若因特殊情形，大會有權通知各參賽者改期作賽或另作編排，如在比賽中發生特殊情況，繼續舉行與否得由當場裁判或大會全權決定，參賽者不得異議。  
The Organiser reserves the right to postpone any match or make any alternative arrangements under special circumstances. Should anything unforeseeable happen during a match, the referee on the spot or the Organiser will decide whether the match should continue or not and participants shall not raise objection.
- (3) 大會不接受參賽隊伍提議的改期申請。  
No application for changing the date of any match from a participating team is accepted.
15. 上訴  
Appeal
- : 大會不設上訴，一切賽果以當場裁判的判決為準。  
No appeal will be accepted. The decisions of the referees on the spot will be final.
16. 領隊會議  
Team Leaders' Meeting
- : 領隊會議定於 2012 年 5 月 25 日(星期五)晚上 7 時 30 分 在新界沙田排頭街 1 至 3 號康樂及文化事務署總部 1 樓視聽室進行。各參賽隊伍的領隊須親自或委派代表出席會議。由於對賽抽籤將於會上進行，沒有派代表出席的隊伍將由康樂及文化事務署職員代為抽籤，並須完全接受抽籤結果。  
The team leaders' meeting will be held at 7:30 pm on 25 May 2012 (Friday) at the Audio / Visual Room, 1/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories. Team leaders of participating teams should attend or send a representative to the meeting. As the fixture draw will be held at the meeting, those teams failing to send representatives will be represented by the staff of the Leisure and Cultural Services Department in the draw and must fully accept the result of the fixture draw.
17. 裝備  
Equipment
- : (1) 比賽時參賽者必須穿着不脫色的運動鞋。  
Participants shall wear non-marking sports shoes during the competition.
- (2) 球隊必須預備兩套合規格而不同顏色的球衣。  
Each team shall prepare 2 sets of approved sports shirts of different colours.

- (3) 如兩隊球隊球衣顏色相同，則按賽程編定排名較先者須更換球衣，或穿着大會提供印有號碼的背心作賽。

If two teams wear the sports shirts of the same colour, the previous team in the competition should change their sports shirts or wear the numbered vests provided by the Organiser.

18. 附則  
Remarks

The definition of “Employee” – An employee who has been working in Hong Kong for the same employer continuously for 4 weeks or more, for at least 18 hours each week and who is still being employed by the same organisation during the competition period.
- (2) 參賽者必須任職於有關機構為「僱員」，「僱員」必須為年滿 15 歲並已為同一僱主連續工作 4 星期或以上，而每星期最少工作 18 小時，並在比賽進行期間，仍然受僱於該機構。  
A participant should be an employee aged 15 or above who has been working continuously for an organisation for 4 weeks or more for at least 18 hours each week and is still being employed by the same organisation during the competition period.
