2. 參賽資格 : (1) 歡迎有興趣的工商機構(如有需要,大會有權要求報名機構提供有關證明,如有效的香港商業登記證)和政府部門以總公司/政府部門的名義參加。  
Eligibility Interested organisations (may be required to produce relevant supporting documents such as Business Registration Certificate) in the name of head office and the government departments are welcome to take part in the competition.
- (2) 參賽者必須任職於該機構,年滿 15 歲並已為同一僱主連續工作 4 星期或以上,而每星期最少工作 18 小時,並在比賽進行期間,仍然受僱於該機構。  
A participant should be an employee aged 15 or above who has been working continuously for an organisation for 4 weeks or more, for at least 18 hours each week and is still being employed by the same organisation during the competition period.
- (3) 參賽者只能代表一間機構,如轉換代表機構,參賽者必須已離開前任職機構,並在該項比賽首場賽事進行時已在新代表的機構連續工作 4 星期或以上,而每星期最少工作 18 小時,並在比賽進行期間,仍然受僱於該機構。  
Each participant can only represent one organisation. A participant may represent another organisation provided that he/she has resigned from the previous organisation and has been working continuously for the current organisation for not less than 4 weeks when the first match of the competition takes place, for at least 18 hours each week and is still being employed by the organisation during the competition period.

5. 費用 : 300 元正

6. 賽制 : (1) 在截止報名後，如有任何組別／比賽項目少於兩人／兩隊報名，該組別／賽事將會取消。  
If the number of participant/team enrolled in any group/event is less than two after the enrolment deadline, the group/event will be cancelled.  
(2) 每名參賽者最多只可參加兩個項目，其中必須包括隊際項目（即參加單打和隊際或雙打和隊際）。  
Each participant may participate in a maximum of two events, one of which must be a team event (i.e. singles and team event or doubles and team event).  
(3) 每項賽事均採用單淘汰制，每局 11 分。  
(大會有關因應報名情況而更改每項賽事的賽制。)  
Single knock-out system will be adopted for each event with 11 points per game.  
(The Organiser reserves the right to change the format of competition for each event in consideration of the enrolment situation.)  
(4) 單打初賽和複賽採用 5 局 3 勝制；準決賽和決賽採用 7 局 4 勝制。  
For singles events, the preliminary and second rounds will adopt the "best of 5 games" system while the semi-finals and finals will adopt the "best of 7 games" system.  
(5) 雙打賽事採用 5 局 3 勝制。  
For all doubles events, each match will adopt the "best of 5 games".  
(6) 隊際賽事採用三場兩勝制，依次為男單、混雙和女單，每場賽事採用 5 局 3 勝制。  
Team Event will be decided by the "best of 3 matches" in the order of men's singles, mixed doubles and women's singles. Each match shall adopt the "best of 5 games system".

Participant(s) who fail to produce valid identification document (such as Hong Kong Identity Card) will not be permitted to participate in the competition(s)/event(s).

For team events, the team leaders/coaches of both teams shall duly complete and submit the participant list together with their team members' identification documents to the officials of the Organiser for verification 15 minutes before the commencement of the match. Participant(s) who fail to produce valid identification documents will not be permitted to participate in the match.
9. 棄權 : (1) 各參賽者／參賽隊伍必須依照大會編定的時間出場比賽；開賽後 5 分鐘仍未能出場作賽或隊際比賽的球員仍未全部到場者，作自動棄權論。  
Each participant/team shall turn up at the scheduled time for the match. Any participant/team that fails to turn up 5 minutes after the official commencement time or dispatches not enough players in a team event will be regarded as having withdrawn from the match.
- (2) 參賽者／參賽隊伍若在單淘汰制的賽事中棄權，會被取消參賽資格，不能繼續參與餘下賽事，而有關成績將停留在其最後一場已參與比賽的位置。  
If a participant/team withdraws from a match under the single knock-out system, the participant/team will be disqualified from playing in the remaining matches. The result that the participant/team has achieved remains at the position held by him/her/it in the last match.

10. 罰則  
Penalty
- : (1) 如參賽者被發現於參賽期間並非該機構的\*僱員，該機構所參與的是項比賽的資格及所獲的成績將被取消。如被發現觸犯此規則超過一次，該機構所參與工商機構運動會全部比賽項目的成績及其參賽資格將被取消。所繳交的費用亦不會獲得發還。

If any participant is discovered that he/she is not the \*employee of the organisation during the competition, the results achieved by the organisation in that particular competition will be cancelled. If the organisation breaches this regulation more than once, the organisation will be disqualified from taking part in this year's Corporate Games and all the entry fee will not be refunded.  
\*The definition of "Employee" is stated at Remarks (1) of Item No. 17.

11. 獎勵  
Awards

12. 裁判  
Referee
- : 大會將邀請香港乒乓總會提供裁判服務。  
Hong Kong Table Tennis Association will be invited to render referee services.
13. 改期  
Changing the Date of Matches
- : (1) 如在比賽當日，天文台於比賽當日首場賽事開始前兩小時已發出八號預警(天文台在發出八號熱帶氣旋警告信號之前兩小時內發出預警信息)、仍發出八號或以上熱帶氣旋警告信號或黑色暴雨警告信號，該日賽事即告取消。賽會稍後會通知各參賽者相應安排。  
Should Pre-No.8 special announcement (an advance notice to the public issued by the Observatory when the tropical cyclone warning signal No.8 is expected within two hours), tropical cyclone warning signal No.8 or above or black rainstorm warning signal is in force 2 hours before the time scheduled for the first match on the event day, all matches on that day will be cancelled. The Organiser will notify the participants of the corresponding arrangement in due course.
- (2) 若因特殊情形，大會有權通知各參賽者改期作賽或另作編排，如在比賽中發生特殊情況，繼續舉行與否得由當場裁判或大會全權決定，參賽者不得異議。  
The Organiser reserves the right to postpone any match or make any alternative arrangements under special circumstances. Should anything unforeseeable happen during a match, the referee on the spot or the Organiser will decide whether the match should continue or not and the participants shall not raise objection.

14. 上訴  
Appeal
